1. Action Africa Help International (AAH-I) is an INGO currently Implementing Primary Health Care (PHC) services in South Sudan, Uganda, Kenya, Somalia and Zambia among other programs supporting up-to 98 health facilities inclusive of Maridi hospital in South Sudan alone.
2. AAH-SS has been authorized by BftW-PADD and USAID-ISDP to implement Regional Primary Healthcare Programme (PHC) in five counties namely Ibba, Maridi and Mundri west of Western Equatoria State and Yei and Morobo counties in Central Equatoria State in the Republic of South Sudan. AAH-SS has been implementing another BftW-PADD financed Photovoltaic and Rainwater harvest equipment installation project in the four counties of South Sudan namely; Ibba, Mundri west, Yei and Morobo since 1<sup>st</sup> October 2014 and it is planned to end by 31<sup>st</sup> December 2015. As part of contractual and institutional requirement AAH-SS is planning to undertake end project evaluation of the PV and Rainwater harvest Installation project.
3. With Technical Assistance of the Consultant, the Grant Recipient intends to apply a portion of the funds to eligible payments under contract for *End Project evaluation of PV and Rainwater harvest equipment Installation in the four counties of South Sudan.*
