CCM - Comitato Collaborazione Medica works with local communities and authorities in order to strengthen and develop healthcare systems and to improve the accessibility and quality of preventative and treatment services.

CCM is currently seeking to recruit a <a href="PHCC Midwife">PHCC Midwife</a> to be employed in Tonj East.

# Objective of the position

Ensure smooth coordination of preventive and curative reproductive health services at the facility, and integrate them within the primary and secondary health care service package offered both at static/facility and outreach level

### **Roles & Responsibilities**

- diagnosing, monitoring and examining women during pregnancy; conduct spontaneous deliveries and refer complicated cases immediately
- promote individual/couple FP to increase utilization rate.
- providing full antenatal care, including screening tests in the PHCC, community and the home;
- identifying high risk pregnancies and making referrals
- arranging and providing parenting and health education for the woman, her partner and family members;
- encouraging participation of family members in the birth to support the mother and enhance both mother/baby bonding and family relationships;
- providing counselling and advice before and after screening;
- offering support and advice following events such as miscarriage, termination, stillbirth, neonatal abnormality and neonatal death;
- supervising and assisting mothers in labour, monitoring the condition of the foetus and using knowledge of drugs and pain management;
- giving support and advice on the daily care of the baby, including breast feeding, bathing and making up feeds;
- providing advice and guidance on a safe and timely transfer home;
- liaising with agencies and other health and social care professionals to ensure continuity of care;
- participating in the training and supervision of junior colleagues; support monitoring of ANC routines drugs and other medical supplies requisition, consumption and control in all health facilities;
- compiling and submitting ANC and deliveries report to CO/In charge; carry out any other duties as deemed necessary by PHCC In-charge

The Midwife must have a certificate in Midwifery or equivalent

- Minimum of 3 years' Working experience.
- Working experience with an NGO or private sector will be an added advantage.
