This Circular is to provide broad administrative directives on above subject in accordance with Sections 39, and 40 (2) (a) of the National Revenue Authority Act, 2016, reinforced by the Resolution 23/2018 passed by the Council of Ministers in their regular setting on 9th November 2018.

All staff are hereby put on notice that effective 1st January 2019, the National Revenue Authority Block Revenue Account shall become operational in the following Commercial Banks.

- 2. Cooperative Bank, South Sudan
- 3. Ecobank
- 4. Kush Bank
- 5. Ivory Bank
- 6. Kenyan Commercial Bank
- 7. Equity Bank
- 8. Buffalo Bank

In this regards, the current regime of remitting revenues into Ministry of Finance and Planning Block Accounts and other Government Revenue Block Accounts seizes to be operational effective 1st January 2019.

This Circular must be circulated across all the stations, collection post, State Offices and borders/Entry Points of Custom and Domestic Tax Revenue Divisions, and Revenue collecting Ministries, Commissions, Departments and Agencies.
