Background: Background: AFOD is a National NGO, supporting Health and Nutrition, WASH (Water, Sanitation and Hygiene) Education & child protection interventions and Sustainable Community livelihoods and rehabilitation and development programs including humanitarian response in South Sudan since 2011.

AFOD in partnership with ADRA-South Sudan is currently implementing an integrated Primary Health Care and Nutrition project in Terekeka State with support from Health Pool Fund 2 (HPF2)

Purpose of the position: The Community Mobilization Officer is directly under the supervision and guidance of the Nutrition Coordinator based in Tali County (Terekeka State).

The Community Mobilization Officer is expected to perform among others the following key tasks and responsibility

Key roles and responsibilities

- 1. Oversee the implementation of nutrition and community and school health promotion and education activities supported by HPFII in Tali County.
- 2. Coordinate with the CHD of Tali County during implementation of the above activities in the county including conducting IRNA and cluster specific gap analysis at each site.
- 3. Participate in monthly coordination meetings for HPFII in collaboration with other members of the project team and the CHD.
- 4. Prepares and submit timely Nutrition, community and school health promotion activity reports to the HPF team in Tali county.
- 5. Participate in the pilot of the Boma Health Initiative in Tali County.
- 6. Participate in supporting all the targeted Community Resource Persons (HHPs, BHTs, VHCs, Mother to Mother Support Groups etc.
- 7. Performs administrative role of supervising all Community Resource Persons working closely with all PHCCs and PHCUs in the County.
- 8. Conduct monthly and quarterly support field monitoring of project sites and prepares monitoring reports on the progress of project implementation.
