FCA is seeking an experienced TVET Teacher Trainers- for the implementation of an EU-funded TVET project in South Sudan. This is a Roving Position and involves frequent travels to field locations. The contract is fixed-term for one year but can be renewed pending funding availability, and proven performance.

PRIMARY PURPOSE OF THE POSITION

To administer Teacher/Instructor trainings to current TVET instructors/teachers on Tailoring and Dressmaking under the EU funded TVET Project in South Sudan using competence based methodologies.

MAIN RESPONSIBILITIES

- Work with Education Coordinator, and TVET Project Officer to create a vision for TVET teacher professional development, in partnership with TVET Technical working group, and line ministries in South Sudan for FCA Country program.
- Organise and Deliver TVET teacher/Instructor trainings across the project locations using competence based methodologies and market driven approaches.
- Provides technical support (coaching, peer learning, and guidance) to TVeT centre trainers PTAs, SMCs, BOGs, and Social Advocacy Teams in the TVET schools on best practices.
- Work to achieve FCA TVET approach and model of "Learning to Earning"
- Support TVET consultants in the development of TVET curriculum and TVET instructional materials for Tailoring and Dressmaking.
- Contribute to monitoring, evaluation and reporting of TVET project activities.
- Conduct field surveys/assessments with partners, and master trainers to determine needs and to obtain baseline data
- Provide regular individualized and group support to TVET teachers/instructors in both methodological and professional development areas.



- Assist with partner(TVET specialized Schools) capacity building exercises
- Assist with partner approach to accountability and reporting requirements through guidance and instruction
- Perform any other duties as agreed with the supervisor.

Responsibilities:

- Instruct groups of seniors in sewing and designing activities
- Commitment to effectively working and supporting seniors
- Ensure that the sewing lessons are inspiring and fun for participants

Qualifications:

- Must know how to sew on a sewing machine and by hand
- Formal education in the field of sewing and fashion designing
- Previous experience teaching sewing lesson is an asset
- Ability to train at all sewing levels, beginner through advanced
- Passion for working and coaching seniors
- Ability to build rapport and work well with the seniors
- Presentation and facilitation skills
- Understanding and sensitivity on issues affecting women and newcomers with lived experience of violence from diverse backgrounds
- Past teaching experience is a requirement and an asset
- Excellent verbal and written communication skills

Emergency Response:

The Teacher/Instructor Trainers as part of FCA's staff may be called to participate or provide support in emergency response situations when and where required in consultation with their supervisor.

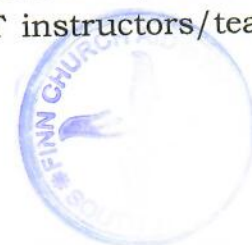
- Work closely with designated project and consortium counterparts

COMPETENCE AND PERSONAL REQUIREMENTS:

Applicants for this position MUST possess the following requirements

Essential

- The candidate should hold a specialised Degree in Tailoring and Dressmaking and production from a recognised TVET institution/university. Diploma is a minimum requirement.
- A minimum of 3 years' experience working with the private and public sectors to deliver market driven TVET trainings to both TVET instructors/teachers, and students.



- Experience, Knowledge and understanding of successful and innovative TVET delivery models and essential quality standards
- Excellent understanding of the South Sudan TVET landscape and familiarity with the main actors in this sector (both public and private)
- Sensitive to gender inclusion in TVET institutions through Right Based Approaches.
- Excellent report writing, presentation and excellent computer skills (at least MS Office package e.g. excel, word, and power point).
- English Language skills is a requirement, and Juba Arabic language skills would be of great advantage.

Desirable

- An understanding of TVET provision for formal and informal employment sectors and community-based entrepreneurial activities.
- Knowledge of ‘wrap-around’ support in TVET e.g. careers advice services, work placement, apprenticeship systems, employment matching etc.
- Experience of working with EU grants.
- Ability to work under pressure, and in extreme weather conditions.

CONTRACT DURATION

One year fixed term contract, including a three-month probation period, will be offered to the successful candidate. The contract is subject to renewal based on performance and further funding. The compensation is based on FCA Salary System and depends on prior work experience.
