PRIMARY PURPOSE OF THE POSITION

Primary purpose of the position: Support field implementation of humanitarian project in Pibor County. "Integrated (Food Security, Livelihoods and Education) Support for returnee and vulnerable host families in Jonglei and Upper Nile State"

MAIN RESPONSIBILITIES

- Provide technical expertise in all livelihood activities related to this project
- Overall coordination of field project activities, under supervision of Humanitarian Program Officer or HC.
- Develop training materials for agriculture training and other livelihood activities
- Ensure project activities are in line with FCA SSUCO annual program strategies and contribute to institutional learnings (best practices and lessons learned).
- Organize and provide livelihood training for farmers and other beneficiaries.
- Support data collection for Cash Programs, Food Security and livelihoods for project monitoring and evaluation
- Attend to beneficiary complaints and coordinate with FCA complaints focal point
- Regular monitoring of agriculture farms, provide technical advice and support on disease and pest control
- Coordinate with other sector partners in implementation of project activities.
- Organize delivery of inputs and other equipment or supplies for beneficiaries
- Keep regular communication with immediate supervisor (Field team leader) and Humanitarian Program Officer
- Prepare and provide regular update on project progress, activity plan and monthly reports.
- Perform any other duties as assigned by the line manager.

- Written and spoken English/ ability to speak local language

- Ability to work in insecure environments and stay in simple living conditions
- Willingness to travel extensively in remote areas
