# Duties and Responsibilities are outlined as below

## I) Procurements:

- Support on development and review of procurement plan for all projects in the region.
- Provide support to local procurements and ensure all procurements are done within organization's guidelines/ procedures.
- Work with Country office logistics officer to ensure project supplies are procured and delivered to project locations/sites on time.
- Ensure adequate controls on inflow and outflow of projects supplies from store to other projects sites,

#### II) Storage

- Ensure that the storage facilities are secure, fit for the intended purpose, well managed and meet health and safe working practice requirements.
- Ensure stores systems and procedures are in place to adequately manage timely inflow and outflow of supplies to respective project locations.
- Ensure weekly/Monthly stores' reports, Stock Management Sheet's, stock counts and all stock records are recorded on both paper and in electronic format
- Oversee stores record reconciliations; comparing stock data with procurement statistics and Packing lists/ Way bills to respective field project locations.
- Ensure standards, stock accountability and records are in place and managed. I.e. Up to date records, insurance, security etc.
- Ensure that -Cuibet office stock/Supplies utilization and replenishment systems are adequate.
- To maintain an adequate supply of basic supplies to facilitate the smooth operation of field office.

- Management of all transport including staff travel bookings, Visa processing and sharing travel documents to respective staff/consultants/other guests in time
- Review and implement process of contracting transport and accommodation services for staff
  and other VSFG clients at state level; i.e. ensure availability of and safe means of transport to and
  from airport, sufficient accommodation services to staff/VSFG clients on transit.
- Review policy on safety driving practice for use by drivers.
- Support country office to ensure all field equipments and automotives have active insurance covers,
- Work with Fleet mechanic to ensure vehicles and related equipments are well maintained and serviceable; i.e. car repairs, equipment, first aid kits replenishment, communications etc.
- Prepare, reconcile and submit monthly fuel utilization report
- Review and supervise vehicle movement and maintenance by ensuring all travels permitted, sufficient control on fuel, car service among others.

## IV) Assets and inventories:

- Ensure that all communications equipment are operational, used in line with communications equipment policy and that requisite training is provided to staff on usage protocols
- Oversee the maintenance of a live, up-to-date Fixed Asset Register ensuring all assets are labeled and current locations of all assets are known and reported,
- Ensure appropriate disposal of assets is followed in accordance with VSFG and donor guidelines,
