Broad description of role

The pharmaceutical technologist is responsible for setting up and the management of the Hospital Pharmaceutical department to ensure uninterrupted supply of medicines and medical supplies to all the hospital departments and ensure that the hospital is able to establish a drug management system.

Accountability and responsibilities

- 1. Manage the hospital medical supply including forecasting of needs and overall management of the hospital medical supplies chain.
- 2. Ensuring that the pharmaceuticals (drugs), medical/laboratory supplies and medical laboratory equipment received from central medical store or donated from other stakeholders conform to specifications.
- 3. Review all the drug orders raised from the hospital departments before they are finally approved for distribution.
- 4. Receive and analyse the monthly drug consumption data from the various departments and generate monthly pharmaceutical reports.
- 5. Provide feedback to the hospital administration on drug consumption and ensure that there are not out of stock.
- 6. Prepare orders for pharmaceuticals and follow up with Hospital Coordinator to ensure delivery to the hospital.
- 7. Give quarterly analysis of the drugs consumptions and improve the existing drug management procedures
- 8. Create a re-order level for all the drugs used in all hospital within 6 months of assignment.
- 9. Assist in preparation and implementation of the required pharmacy protocols and ensure there adherence at all times to promote rational drug use.
- 10. Provide training on proper pharmaceutical and dispensing procedures to the team members when called upon.
- 11. Any other duty as assigned by the line manager.

Qualifications and competences

- Minimum qualification is a diploma in pharmaceutical technology or a degree in pharmacy from a recognized institution, with at least 2 years post qualification working experience.
- Should be registered by the relevant regulatory body to practice.
- Computer literacy skills with proficiency in MS word. MS Excel. MS Access an added advantage
