2.1 Reporting Line: Project Manager Emergency Preparedness & Response

Purpose of the position:

Reporting to the Project Manager that is based in Juba, the Project Officer will be responsible to implement a multi-sectorial emergency preparedness & response the implantation of the SSJR2 project activity. S/he will be responsible for assessment, planning, implementation, monitoring, capacity building, reporting and coordination with UN clusters, local authorities, other key stakeholders and local partners.

2. Key Responsibilities and Accountabilities:

Project Management

- Support the Project Manager in planning and implementing project activities to meet key deliverables based on timeline and scope agreed with the donor;
- Ensure beneficiary targeting takes place in line with agreed criteria and in such a way that is transparent and accountable, compliant to CORDAIDs standards and commitment
- Liaise with key stakeholders at project field level, government authority, cluster system, national and international organizations;
- Support Project Manager in organizing meetings and community engagement sessions, including conducting community workshops related to food security, Hygiene promotion, WASH infrastructure and community WASH/assets rehabilitation.
- Participate in and ensure effective monitoring and evaluation system design, and implementation for all
 aspects of the project including monitoring against technical indicators, progress by developing and applying
 monitoring tools to inform reports to senior management
- Ensure in confidential & secure filing and record keeping of project activities at field level.
- Supervise and support community mobilisers & volunteers in delivering result areas for the project.
- Conduct himself/herself both professionally and personally in such a manner as to bring credit to CORDAID.
- Other assigned tasks, as necessary
- Provide insightful information and assist in developing proposals





Documentation and Analysis:

- Document successes, failures, lessons learned, and stories from the field
- Conduct surveys, needs assessments, and data and information collection for on-going programming
- Provide reporting on time according to deadlines and to meet donor and HQ reporting on projects.

Monitoring and Evaluation:

- Provide regular reporting, analysis of data, on weekly and monthly basis
- Provide oversight, training, data management support (forms, tools, monitoring systems) and guidance to concerned project staff.

Representation & Coordination:

- Focal point for project activity at field level, and maintain regular contact with Juba level on all aspects
- Liaise frequently with UN agencies, cluster and other NGOs working in the assigned area.
- Ensure that local NGOs have opportunities to offer field insights and reflect on program progress and effectiveness.

Other

- Undertake CORDAID work in a manner that upholds the organisational value and integrity, and dignity and value for beneficiaries.
- Act in accordance with Security protocols and instructions from line Manager
- Assist in promoting CORDAID EPR among beneficiaries, local authority and its alliances & partners
- Conduct himself/herself both professionally and personally in line with the Humanitarian Code of Conduct
 and in such a manner as to bring credit to CORDAID and not to jeopardize its humanitarian mission.
- Any other duties that can reasonably be asked from the position.

Qualifications, skills and competencies:

- Degree or equivalent in community development, agriculture, water and sanitation, socio-economic studies, or related field;
- At least 3 years' relevant work experience, including 1+ years' experience of delivering emergency response and recovery programmes (e.g. food security, WASH, shelter/NFI, health/nutrition, protection).
- Practical experience in project cycle management and proposal writing.
- Good understanding on cluster system and experience in coordination with various actors at the field level.
- Practical experience of working with local partners.
- · Strong reporting, analytical and problem-solving skills; strong team player
- Willingness to live in field location with very basic facilities.
- Excellent English writing and communication skills; knowledge of local languages an asset
