JOB OPENING ECONOMIC SECURITY FIELD OFFICER II Based in Bor

The International Committee of the Red Cross (ICRC), an impartial, neutral and independent organisation striving to protect and assist the victims of war and internal violence, has been working in South Sudan since 1986. The ICRC is looking for an enthusiastic and motivated person for the above position based in Bor.

Main Duties and Responsibilities:

- In close collaboration with EcoSec delegates, coordinates and implements agro, livestock and relief programs with relevant local authorities and actors.
- Ensures that all field trip reports are submitted to the line manager in a timely fashion.
- Provides regular updates to line manager on Food security related issues particularly the impact of displacement and conflict on the livestock, agriculture, fisheries, people coping mechanisms and vice versa in the program location.
- Involves in development, implementation and monitoring of agro, livestock and any livelihood related projects in Bor Sub Delegation.
- Performs various data processing on computer independently mainly FSS (Field Supply Systems)/ logistical documentation).
- Maintains a clear record/ trail of financial advances issued to the field officers updating line manager and ensuring timely clearance of cash advance.
- Involves in planning and distribution of agricultural seeds, tools and other agricultural inputs; technical familiarity with seeds and tools relevant to the context as well as animal health (fisheries included).

Minimum required knowledge & experience:

- Bachelor Degree, some college coursework completed, an Associate Degree of equivalent higher education degree in a humanitarian area, socioteconomic development, Veterinary Science or equivalent field
- Additional vocational training in a humanitarian area, socio-economic development, humanitarian law, human rights or equivalent position
- 4-6 years of experience in a humanitarian area, Veterinary Science, socio-economic development, humanitarian law, human rights or similar field
- Advanced conversational in English and Arabic.
- Expert level in computer skills.
- Skilled in the following competencies: representing the ICRC; Networking & Communication; adapting & learning; responsibility & autonomy; communication (ability to express views and ideas); analysis & synthesis.
- · Good knowledge of ICRC mandate, IHL, and of other humanitarian topics
- Good knowledge of geographically assigned environment
- Readiness to spend 50-75% of the time in the field
