The role of the Nutritionist is to provide technical leadership in regard to Nutrition Programme and oversee implementation of nutrition service delivery in Lainya County, Yei River State. The Nutritionist, will lead administrative and technical tasks of planning, organising, supervising, treatment and implementation of nutrition programme. He/She will mentor and supervise the Nutrition team to promote high quality nutrition implementation approaches. He/she will conduct various trainings on nutrition protocols, SMART surveys, and supportive supervision activities. He will perform assigned management duties closely working with other internal departments, to ensure high performance and smooth running of nutrition programme activities.

The Nutritionist will work in close collaboration with the MoH, SMoH, the CHD and the nutrition cluster. S/he will provide supervision, technical support and direction to Nutrition operations, and ensure that nutrition interventions are in line with MOH health policy, CMAM and IYCF guidelines.

#### Major Responsibilities

- Ensure the nutrition projects are implemented in line with MoH nutrition guidelines and project documents ( LGF, work plan and budgets)
- Provide regular and consistent technical support to health workers and CHWs at health facilities
  and during outreaches through monthly targeted On-Job-Training, regular mentorship and
  regular supervision with an aim of capacity building them.
- Ensure that community nutrition volunteers are adequate trained and supervised.
- Ensure quality nutrition interventions are provided to target population.



- Set up a commodity supply system and ensure that CMAM supplies are well managed and stock out prevented. Monitor Supplies for SFP/OTP/SC and ensure records are well kept.
- Monitor closely the implementation of the project and ensure that targets are reached.
- Ensure data for the Nutrition Information System (NIS) are submitted on time.
- Contribute in the development of training curriculum, and data collection tools
- Facilitate or co-facilitate nutrition related trainings for health Workers e.g. IMAM, IYCF and other HINI components.
- Ensure that all the community structures are established and functional.
- Support the systematic delivery of Health, Hygiene and Nutrition education messages to the target program beneficiaries and the entire community.
- Submit regular progress report to the project Manager for continuous assessment of the effectiveness and the impact of the program

#### **Main Duties:**

The Clinical Officer of Primary Health Care Centre (PHCC) is responsible for implementing all activities grouped under this level in the MOH guidelines. He/she is responsible as an overall in-charge. By virtue of his designation, it is implied that she or he will be solely responsible for the proper functioning of the PHCC, and all its activities relating to Reproductive Health, Child Health, EPI/Immunization, and Nutrition, Curative and health promotion, PHC Centre management and other national programs. The outline of the duties includes:

Responsible for daily curative consultation and patient management

Organizing the pharmacy, dispensary, outpatient, maternity, laboratory, EPI section, in-patient departments, minor theater and supervise duties of the PHCC staff to ensure smooth running of the facility activities.

Ensure quality assured laboratory services are provided for cases that require investigation for

proper management. Ensuring health promotion and education guidelines are followed by all the staff as per MOH

guidelines. Ensuring EPI (both static and outreach) micro plans in his/her catchment area are displaced and implemented, Nutrition services, Reproductive Health services and curative services are provided as per MOH guidelines.

Daily ward rounds and meaningful patient assessments and management and where possible

early referrals for cases that cannot be managed at his/her PHCC. Ensuring infection prevention and hospital waste management protocols and guidelines are

respected in all the departments of the PHCC. Working with the county health department on integrated disease surveillance and response and

ensure prevention of communicable diseases.

Carrying out PHCC administrative work

Ensure that all prescriptions and medical procedures should be done with ethical considerations and following the RSS MOH guidelines and policies.

The Midwife is responsible for implementing all the maternal child health activities, health education promotion for mothers. She shall be responsible for all activities in the maternity department in coordination with the Facility In-charge.

#### Main responsibilities

- Responsible for provision of quality maternal and neonatal health services at the PHCC, respecting minimum standards of care and supporting the PHCU within the given jurisdiction on the same i.e. the Payam with maternal Child health activities. Maternal and neonatal health services including: Focused Antenatal care, deliveries, neonatal health care to prevent infection and promote health (infection prevention, exclusive breastfeeding, immunization, growth monitoring and check-up for common neonatal infections), postpartum care, PMTCT and encouragement of breastfeeding/young child weaning & feeding, family planning, and managing obstetric emergencies including referrals as appropriate, & STIs management according to MOH guidelines.
- Provides supportive supervision and on job training of MCHW and TBAs to ensure that they carry out their duties as required
- Provides health education to patients coming to the health facility and also plans community based activities
- Participates in EPI activities and ensures all newborns from the facility receive OPV0 and BCG before discharge and ensure all mother are immunized against Tetanus.
- Identification of obstetric emergencies and appropriate management, for example APH, Complicated labor and PPH, Post Abortion Care.
- Provision and promotion of PICT and PMTCT services for all Antenatal and post-natal mothers.
- Participate in prevention and response activities for SGBV survivors, including awareness raising and medical care for survivors of Rape (CMR).
