- **Based in:** Yei - Yei River State - Central Equatoria

## TERRE DES HOMMES

Terre des hommes (Tdh) is a non-profit, non-political and non religious humanitarian NGO. Its objective is to steadily improve the conditions of the most vulnerable children worldwide. Tdh is implementing humanitarian activities in South Sudan since 2014, supporting population with Food Security, WaSH in schools and Child Protection in Yei River State and in Juba.

## CHILD PROTECTION

Tdh is a leading Child Protection Agency. Tdh highlights the importance of protecting children among its programs in accordance with the United Nations Convention on the Rights of the Child (CRC) and in the best interest of the child.

## FSL PROJECT

The Food Security & Livelihood project will be implemented in Yei from January 2019 and will include three components: Farming Support (seeds and tools distribution), Cash for Work and Restocking of Livestock. The overall aim of the project is to contribute to the restoration of productive agricultural inputs for the crisis affected communities in Yei town.

## GENERAL OBJECTIVE

Under the supervision of the Food Security and Livelihood Officer, the primary role of the Livestock Monitor will be to support the implementation of restocking of livestock which aims to strengthen the resilience of the local breeder by providing livestock (goats, chicken, rabbits and poultry). He/she will be responsible for the training and capacity building of local breeder benefiting from Tdh livestock distribution.

## SUPERVISION

- Under the direct supervision of: Food Security & Livelihood Officer
- Supervision of: FSL Outreach Workers

## RESPONSIBILITIES AND TASKS

1. **Programme implementation**
  - Prepare order requests for inputs necessary to programme implementation.
  - Manage beneficiary selection in cooperation with the local communities and based on Tdh vulnerability criterion.
  - Ensure the selection of livestock supplier.
  - Carry out household surveys.
  - Initiate and manage the beneficiary registration and verification processes.





- Conduct regular post distribution monitoring of beneficiary households.
  - Supervise and train the CBO outreach worker on implementation.
  - File all contracts and agreement with communities.
  - Following the agreed-on plan of action, implement the program to schedule, reporting any delays and deviations immediately.
  - Regularly conduct surveys and focus group discussions to determine beneficiary's satisfaction on restocking and services.
  - In consultation with the Accountability and M&E Staffs, ensure all complaints from communities are addressed and adequate feedback is timely provided.
  - Initiate and manage the beneficiary registration and verification processes.
  - Advise livestock owners on disease control and animal husbandry methods.
  - Provide training to project Extension Agents on cattle management and animal husbandry.
  - Advise entrepreneur owners on better use of animal feed, housing, water, and other important aspects of broiler, breeder, hatcheries and layer farming and poultry rearing.
2. **Collaboration in the communities**
- Actively participate to the good collaboration with local leaders.
  - Explain the project and Tdh restocking of livestock related activities to the community members.
  - Act as a liaison with the local population and authorities in order to identify the needs, grievances and major events that could have potential consequences for Tdh activities.
3. **Communication and representation of Tdh**
- Report to the FSL Officer on the progress of activities and specific tasks assigned, problems encountered, the quality of relations with beneficiaries.
  - Address any issues on the field with the beneficiaries or the community members and tell the Line Supervisor.
  - Represent Tdh at anytime and anywhere when he/she is on duty.
4. **Team working**
- Participate with the FSL team to identify, formulate and propose activities based on the needs for the new proposal/project.
  - Support any FSL activities when it is required (for surveys, distribution, etc.).
5. **Reporting and monitoring**
- Collect data, pictures from the field to provide to the FSL Monitor.
  - Collect complaint feedback.

The tasks and responsibilities defined in this Job Description are not exhaustive and can evolve depending on the project needs. The employee could be requested to perform other tasks as his/her Line Manager may judge necessary.

## SKILLS AND EXPERIENCE

- **Language:** Fluent in English, Juba Arabic and Kakwa
- **Work experience:** 1 year relevant experience in implementing livestock activities. Additional professional technical skills or training in livestock management is an asset.
