## Job Summary:

The Agro-enterprise Coordinator will support value chain development and agro-enterprise amongst selected producer groups (agriculture, livestock keepers and fisher folks) and Savings and Internal Lending Communities (SILC) groups which have potential to access markets. S/he will work hand in hand with the SILC team to introduce and promote access to savings and credit using the SILC model promoted by CRS. S/he will plan and implement strategies aimed at establishing or strengthening market linkages along the value chain to support producer groups and SILC groups. Working closely with Agriculture Officers and Project Managers s/he will play key role in organizing and facilitating trainings and capacity building to staff members, Field Extension Agents, stakeholders and partners on the development of business and agroenterprise skills, as well as supporting households in developing profitable value chains in fisheries, agriculture and livestock production.

The post holder will be a member of the Livelihoods and Agriculture Team and reports to the Economic Strengthening Technical Advisor. As a member of a multi-disciplinary livelihoods team, s/he will provide appropriate and timely input to other technical sectors to achieve the overall project objectives. S/he will plan and execute training and programming in collaboration with the Technical Advisor - Economic Strengthening to ensure that agro-enterprise and group strengthening is built into all activities with producer groups and SILC groups.

## Job Responsibilities:

- In collaboration with the livelihood team, plan and implement agro-enterprise interventions, including community mobilization, group formation and institutional building, marketing opportunities identification, marketing and business management and access to appropriate financial services.
- Support and guide producer groups and SILC groups institutional building and strengthening, including communication, meeting and group organization, accountability and management of group assets and resources, internal democracy, etc.
- Develop and organise training for other LRRP program staff and extension agents on producer groups and SILC group institutional strengthening and agro-enterprise including marketing, business management and entrepreneurship.

- Assist in developing guidelines and training materials on producer group internal governance and capacity building for partners and extension agents.
- Support the Agriculture and Livelihoods Officers, SILC Officers and Field Extension Agents in the planning and implementation of businesses and agro-enterprises for men, women and youth within the producer groups and SILC groups.
- Work with the program technical leads and project managers to identify and develop profitable value chains.
- Support the development of market access including facilitation of community-private buyer and community- private supplier linkages.
- Assess the capacities of in-put suppliers and in coordination with the Technical Advisor -Economic Strengthening develop program for capacity building to support LRRP's strategic objectives.
- Conduct value chain assessment and agro-enterprise potential mapping to develop an intervention plan in LRRP operational areas.
- Identify market opportunities and develop training and other capacity development geared to maximise the participation by women.
- Promote and support the establishment of savings and internal lending communities within producer groups and direct them towards the institutionalization of the SILC model as appropriate.
- Conduct regular monitoring of agro-enterprise and institutional capacity building components and design appropriate tools to do so as well as participate in overall program reviews and evaluations.
- Carry out other duties in the Livelihoods sector as identified by the supervisor.

**Scope:** The Agro-enterprise Coordinator will be responsible for ensuring the success of the marketing activities across all the counties. S/he will work directly with the Agriculture and Livelihoods Officers plus the Field Extension Agents to achieve this success.

## Typical Background, Experience & Requirements:

- Bachelor's degree in Agriculture, Rural Development, Economics, Business Administration or a related subject from a recognized university;
- At least 3 years professional work experience related to agribusiness development, small business support, livelihoods value chains development, strengthening farmers' groups.
- Proven capacities in participatory planning and evaluation at community level.
- High level training and facilitation skills with program teams and beneficiaries.
- Proven experience in working with government and non-government local partners.
- Understanding of monitoring and evaluation techniques, participatory planning and implementation.
- Experience using MS Windows and MS Office packages (Excel, Word, PowerPoint).

Strong interpersonal skills, demonstrated in cross-cultural setting.

**External:** Local implementing partners: Nile Hope, Caritas- Rumbek and the Government line ministries; other partners operating within the project areas.
