In 2009, PSI started a Home Management of Malaria (HMM) program for children under five years old. Since then, HMM has evolved into a broader Integrated Community Case Management (ICCM) program with the addition of pneumonia, diarrhea and acute malnutrition interventions.

Last Mile distribution of health commodities and Long lasting insecticide treated mosquito nets (LLINs)

- Ensure effective daily coordination of the Malaria Project implementation of all Global Fund programs implemented by overseeing implementation of Malaria activities in all PSI designated areas.
- Account for all health commodities and LLINs, properties and materials related to mass campaign given for use by psi to execute the campaign.
- Collaborate with National Malaria Control Program (NMCP), Count Health Department (CHDs), field officers and county-implementing partners for effective health commodity distribution and LLINs, participate to supervision and capacity building of all field teams orienting them on tools and Standard Operating Procedures (SOPs) designed to support the project.
- Manage and develop monthly and quarterly activity budgets and work plans; conduct regular performance reviews of field Malaria project staff.
- Provide logistical and program oversight of daily activities of PSI LLIN projects.
- Collaborate with NMCP, SMOH, CHDs and CIPs to ensure that the implementation of malaria activities is undertaken in a smooth manner by conducting trainings on Health commodity distribution and LLIN distribution
- Ensure that registrars correctly follow distribution methodology on distribution day including:
- Opening bags and removing nets
- Proper collection of Voucher Tokens/wristbands
- Ensure that waybills are correctly signed
- Accurate distribution of nets to beneficiaries
- Proper collection of signatures or fingerprints verifying receipt of nets
- Proper calculation of the data collected and reports
- Reporting: compiling reports, reconciliation of health commodities and LLINs delivered versus reported, investigating any differences
- Quantification and forecasting of LLINs with the support from MOH, and procurement and supply chain function
- Ensuring communication through the PSM manager, to DC and the Ministry of Health to ensure procurement of health commodities and LLINs is as per MOH technical Specifications
- Obtain tax exemptions and work with the clearing agents to clear commodities at the port of entry.
- Receiving and reconciliation: Confirmation of quantities and ensure completeness of the orders at the Central Medical Stores (CMS) and CHDs



 Delivery to drop location and distribution: coordinate delivery to the states/counties and drop locations working more closely with the MOH,SMOH, CHDs, CIPs and the transporter

Health commodities and LLINs distribution Management

Ensure effective systems are in place to track health commodities and Long Lasting Treated Mosquito nets from the point of receiving, storage, dispatch of health commodities at Central Medical Stores (CMS) and at partner or distribution level. Tracks inventory movement and details to the health facilities or until possible disposal level.

- Designing of health commodities and LLIN tracking tools for efficient last mile distribution. Ensure correct and complete filing of records before, during and after distribution of health commodities and LLINs
- Receiving and reconciliation: Confirmation of quantities and ensure completeness of the orders at the CMS and CHDs
- Work with the County Implementing partners to ensure accurate consumption data of health commodities is maintained.
- Conduct field visits to review the stock status levels at the health facilities and any indication of stock outs
- Conduct training at the CHD on inventory management
- Prepare weekly and monthly activity reports for the SPSCM review and onward submission to the PSM Manager
- Any other duties as assigned

- At least Diploma in the either Purchasing and Supply, Material Management and Administration, Business Administration with two (2) years of experience in large logistics and inventory management in an international Non-Governmental Organization
