#### Purpose of the position:

Direct implementation of economic reintegration activities for released CAAFAG children in Yambio County. The officer will support in coordinating with the Vocational Training firm at Tindoka to specify the topics of the VT, and coordinate with local shops and market to facilitate the placement of released CAAFAG children in apprenticeships for those who wish to peruse a different career pathway or learn a different type of skills. The officer will also be responsible for day to day follow up and the children and monitoring of the activities as well as coordinating with relevant departments within World Vision

#### Major Roles and Responsibilities of the Economic Reintegration Officer

- Provide overall coordination and management of economical reintegration activities provided for the released CAAFAG children residing at the ICCs and in the community in Yambio County.
- Assess the preferences of the released CAAFAG children residing at the ICCs and compare it to the market needs in order to determine the Vocational Trainings to be provided at Tindoka.
- Coordinate with the firm providing the VTs in Tindoka to set up the activities and register the interested children accordingly.
- For children who express interest in topics not provided by the firm (hairdressing, Salon Management, Agriculture, etc), coordinate with local shops and markets to facilitate apprenticeships to place these children and build their capacities and skills accordingly.

- Identify children or group of children who could benefit from a financial/material support to start up a small scale business.
- Insure regular follow up and monitoring on the children attending the VT and those placed in apprenticeships to make sure they are not exposed to any harm or other protection risks.
- Prepare project documentation, including attendance sheets, weekly planning and monthly
  project reports on implementation status, quarterly and final narrative reports as per donor
  requirements and sending them to CP Project Manager, CP Specialist, Project Coordinator and
  other relevant team members for review/further action within set deadlines.
- Liaise with WVSS Grants division in tracking project expenditure, reviewing financial reports, and addressing queries related to expenditure in timely manager.
- Coordinate with relevant departments and personnel within WVSS to insure required services are provided in a qualitative manner.
- Carry out any other duties as delegated by management

# Qualifications: Education/Knowledge/Technical Skills and Experience

The following may be acquired through a combination of formal or self-education, prior experience or on-the-job training:

- Bachelor's Degree in Social work and related discipline preferred
- Experience in conducting non-formal market assessments and economical reintegration activities.
- · Familiarity with Vocational Training and apprenticeships programming.
- Ability to work in high tension and high security risk situations and be able to adapt to rapidly changing contexts.
- Knowledge of and adherence to the Red Cross and NGO Code of Conduct and capability of incorporating standards in design, implementation and evaluation of relevant projects.
- Computer literate
- Working written / speaking English
