



# JOB OPPORTUNITY – MONITORING AND EVALUATION OFFICER- CUEIBET

## **Background:**

VSF SOUTH SUDAN seeks to recruit An M&E Officer a BMZ-funded livelihood project (2.8 Mio Euros) from October 2016 till July 2017, implemented in Lakes States, South Sudan. Duty station is Gok State (Cuibet County)

The initial contract will be for 12 months with possibility of extension dependent on performance. This position is based in Cueibet with travels to field locations. The post holder will undertake the following duties/ responsibilities:

#### **JOB PURPOSE**

The Monitoring and Evaluation Officer (M&E Officer) will provide support in monitoring and evaluating ongoing projects in the named regions. The incumbent will be responsible for overall M&E and learning needs of the project and will generate evidence based on real data to show the performance of the project. The incumbent will also play an active role in promoting key learning for the improvement of the project and for wider learning across the organisation.

#### MAIN DUTIES AND RESPONSIBILITIES

- To supervise regular data collection by the project team and ensure quality of the data by random verifications and validations;
- To record, manage and preserve monitoring and evaluation data in a safe and accessible way
- To analyse and discuss findings based on regular monitoring data; including generating M&E reports
- To provide technical support on M&E and evidence-based recommendations to the project manager
- To ensure that implementation of field activities adheres to VSF's M&E systems and quality assurance
- To support project staff and partners in conducting baseline surveys and other relevant studies
- To participate actively in programme planning processes and periodic reviews as required
- To support the larger programme within Warrap and country level in developing organizational reports

### **Qualifications and experience required**

- Degree in relevant field with proven experience and training in monitoring and with elements of measurement (theory and practice);
- At least two years of experience in a position with similar responsibilities and tasks; competency in social research methodology, statistical methods, reporting and presentation;
- Demonstrated competency in training, facilitation, coaching and mentoring skills;
- Demonstrated competency in systems analysis, review and design;
- Good contextual knowledge of the South Sudan social, cultural and economic context, priorities and constraints.
