Back Ground	<p>War Child Canada (WCC), a registered Canadian charity that provides humanitarian assistance to children and families affected by war, War Child Canada works with war-affected communities to help children reclaim their childhood through access to education, livelihood and justice. War Child takes an active role in raising public awareness around the impact of war and the shared responsibility to act.</p> <p>With Country Office in Juba, WCC has operation bases in Torit, Wau and Malakal, from where field program deliveries are coordinated. To support livelihood intervention, War Child Canada is looking for a qualified individual to fill the position of Livelihood team leader based in malakal, South Sudan.</p>
Position Summary	<p>The Livelihood team leader will ensures that the War Child Canada's interventions are timely, well planned, resourced and accountable to beneficiaries and stakeholders. He or she is responsible for coordinating, leading and managing successful implementation of War Child Canada (WCC) Livelihood projects in Malakal. The team leader will contribute to the development of a Livelihood Strategy, including writing of proposals, conducting needs assessments, managing project planning, implementation monitoring and evaluation. He or she will also be responsible for providing technical guidance, ensuring high-quality activities are implemented in a timely manner. In addition, the livelihood team leader will ensure the coordination of all Livelihood activities through active participation in coordination meetings and working groups.</p>
Responsibility	<ul style="list-style-type: none"> • Provide management oversight and technical guidance to the Livelihood projects ensuring that all interventions are of quality, in compliance with the project proposal and standards such as those defined by the SPHERE Project; • Prepare/review detailed implementation plans and ensure timely scheduling of activities, budget phasing, monthly cash forecast, cash monitoring; • Involving female and male children, youth and adult, implement preparatory activities required for successful project implementation, including but not limited to; work planning, effective mobilization of beneficiaries and stakeholders for project implementation, conduct market assessments to inform viable livelihood options fit to the context as well as ensuring baseline data is compiled, analyzed, the M&E system is in place, the tools for data collection & analysis are in place.

- Ensure that the livelihood activities including conditional and unconditional cash transfer, VSL, fishery, agricultural and livelihood skill training are timely delivered, appropriate, meet quality standard and the security measures.
- Apply and supervise community based targeting approach to identify beneficiaries for various livelihood activities, based on selection criteria agreed by the community and in consultation with local actors on eligibility criteria.
- Lead the team to verify and assess feasibility of identified livelihood activities including cash for work activities; ensuring that the activities will enhance livelihood recovery, assets protection and community development.
- Together with stake holders determine work unit for each cash for work activities, link the unit to cash value, determine the acceptable standard of each work unit and supervise cash distribution to beneficiaries.
- Link up with operations department to ensure timely procurement and distribution of tools and material required to implement the project;
- Ensure that staffs are adequately trained to effectively implement quality project activities including cash transfer, VSLA, fishing, agriculture and vocational skill.
- Together with project team & stakeholder ensure that suitable member of the beneficiary are identified and adequately trained to perform the role of project committee.
- In collaboration with Logistic & Finance, plan for safe cash distribution to beneficiaries, ensuring timely distribution of cash based on completed work unit and adherence to cash handling procedures.
- Ensure that Post distribution monitoring is done for every round of distribution; and to ensure that the data correctly analyzed and conclusions discussed within the staff in South Sudan and HQ in Toronto;
- Document and record the implementation process and the progress of the project for learning and advocacy and ensure periodic reporting (regular production of M&E report, monthly and quarterly reports) to the donor, government partners and to War Child Canada;
- Ensure that the work of all staffs are supervised, supported and evaluated to ensure effective implementation of the livelihood project and ensure that the project team have adequate resources to timely deliver project outputs and objectives.
- S/he will improve livelihoods of children and their families through the application of a range of appropriate livelihood options that is informed by livelihood needs assessment, analysis of markets and population capacities
- Support the Implementing Partner by providing technical and non-technical management support / advice on planning, implementation, monitoring and evaluation of projects.
- Operate and behave in a manner that is consistent with the War Child Canada's child protection policy, Code of Conduct and gender mainstreaming approach.
