Job Description

CMD is looking for a qualified Livelihood Facilitators (3) who will work in Longechuk County providing Livelihood capacity building for the youth in Mathiang and the other in Udier Livelihood centres. The Incumbents will be directly answerable to the Education Officer. The job functions will include but not limited to the followings:

Duties and Responsibilities

The Livelihood Facilitator (s) should be able to:

1. Support in the planning, organization, implementation and monitoring of Youth skills acquisition and Livelihood activities.;
2. Facilitate the design, monitoring and evaluation of activities aimed at the economic strengthening of households and communities to reduce reliance on aid.
3. Ensuring timely implementation of all planned action phase/livelihood related activities
4. Collaborating and networking with district and community partners in order to ensure ownership of the project;
5. Send monthly report on enrolment and all other activities with a success story to CMD Education Department in Juba
6. Supporting the establishment and strengthening of non-formal or functional literacy and numeracy programs, technical vocational education, livelihood and enterprise development opportunities, that provide targeted support and opportunities to youth
7. Mobilise out- of –school youth to attend the trainings at the Livelihood centres;
8. Provide monthly report, evaluations and other reports on the activities of the Livelihood centre and share with Education Officer;
9. Attend to any other duties as the office may deem necessary.

Required qualification / Skills/Experience:

- ❖ Secondary school certificate; a diploma is desirable but not the minimum requirement
- ❖ 2 years of relevant experience in technical skills facilitation and coaching
- ❖ Must be able to learn quickly and adapt to CMD's operation principles
