1) Introduction

Action Africa Help International (AAH-I) South Sudan is calling for quotes from competent and reputable Contractors to provide construction services and supply of construction materials for renovation of Juba and Yei Logistics Bases.

Interested contractors are requested to submit their quotes based on the provided BOQs which can be downloaded from AAH–I website while hardcopies can be picked from AAH-I Juba Logistic Base.

2) Submission of quotes:

3) Marking and Labeling of submissions:

Hard Copy Submissions MUST be contained in securely sealed envelopes, clearly marked and labeled as follows:

"Quotations for Provision of labour and materials for renovation of AAH-I Juba Logistics Base Ref: CFQ/AAHI-SS/Juba/renovation works/6088/add Lot number

And/Or

"Quotations for Provision of labour and materials for renovation of AAH-I Yei Logistics Base Ref: CFQ/AAHI-SS/Yei/renovation works/6089/add Lot number For online Submission, the same marking and labeling MUST be contained in the Subject line of the email and the attachments MUST be in pdf format strictly.

NB: All national contractors must be legally registered in South Sudan and should have official office with some verifiable construction equipments in number and quality required for the indicated works.

4) Registration of bids

Please ensure that, you register your hand-delivered bid with the Procurement department and drop it in the bid box yourself before you leave the Procurement office. Each Lot must be registered individually on the bids submission forms which will be availed. Unregistered bids will not be considered even if they are dropped in the tender box.

5) Submission deadline:

The deadline for submission of quotes shall be 6th of November **2017**, **15:00hrs** (East African Standard Time). Any late submission shall be rejected.

6) Terms of trade and details of quotes:

Currency: Quotes should be drawn in US Dollars Strictly

Quotes must be submitted by Lots as per the BOQs

Payment: Payment shall be made via Bank Transfer within 30 days from completion date.

Award of Contract:

A comprehensive evaluation criterion (including but not limited to; comprehensiveness of quotation, proposed duration, experience, indicated quality details and price), that ensures Value for Money on the side of AAH-I, shall be followed in determining the Contractor to whom the Contract shall be awarded. AAH-I South Sudan is not obliged to award the Contract to the lowest priced offer or any Contractor. The decision of AAH-I South Sudan's Procurement Review Committee shall be final.
