Vision: A world where no child knows war.

War Child Canada's Mission: War Child Canada works with war-affected communities to help children reclaim their childhood through access to education, opportunity and justice. War Child Canada takes an active role in raising public awareness around the impact of war on communities and the shared responsibility to act.

Partnership Statement

War Child Canada's local investment and capacity building model centres on the capacity of individuals, communities and partner organizations to independently deliver program activities. This model emphasizes accountability to partnership principles and the organization's accountability to civil society, children, youth and women's groups, government, networks, coalitions and local partner organizations, partners, communities, and other stakeholders with whom War Child Canada its partners work. War Child Canada frequently works in humanitarian settings. However War Child Canada's programming approach differentiates itself to other organisations in these contexts who are frequently providing emergency aid. Education, livelihoods and legal protection programming requires a different approach, that builds partnerships that result in longterm community ownership, stemming from the engagement of local communities at each step of the management cycle.

Key Selection Criteria;

- 1. Strong program Design, Implementation and sound financial management
- 2. Expertise in thematic areas such as; Education (ECD, ALP, FLN, Basic and Secondary Education etc.), Justice (Child Protection, GBV and Access to Justice) and Opportunity (Capacity building, Livelihood and FSL etc.).
- 3. Capacity to respond to Emergencies, Resilience and long term Development
- 4. Women & children focused organizations with capacity building as stated goals
- 5. Transparency and Integrity in fund management

Key partnership principles:

- 1. Must conform to NGO legal requirements as prescribed in NGO Act as amended 2016
- 2. Must have strong institutional management framework e.g. Financial, programmatic and Monitoring and Evaluation mechanism etc.
- 3. Programs should lead to social/financial empowerment of beneficiaries and communities
- 4. Must have capacity to respond to emergencies, build resilience and where possible engage in long term development
- 5. Must have organized systems of program execution with clearly defined goals and objectives



Eligibility:

To be eligible to collaborate with WAR CHILD CANADA (WCC) South Sudan, an NGO must meet following criteria and submit relevant documentation:

- 1. Evidence of registration as an NGO (national/International) in South Sudan
- 2. For national NGOs, evidence of an active board of directors which meet at least twice a year
- 3. Non-affiliation to any political party as stated in the constitution or by-laws
- 4. Evidence of annual audits for the past 3 years, submitted to concerned stakeholders.
- 5. Organizational profile which reflects alignment to the mission of WAR CHILD CANADA (WCC) as demonstrated by conforming to Partnership agreement (to be signed between the NGO and WAR CHILD CANADA (WCC)
