Case Containment Center (CCC) Manager – Rumbek



The Carter Center (TCC) provides technical support to the Ministry of Health – Republic of South Sudan for the Guinea Worm Eradication and Trachoma Control programs. The Carter Center is currently seeking a dynamic, qualified candidate for the following temporary post in South Sudan.

Title: Case Containment Center (CCC) Manager (1 position)
Duty Station: Rumbek, South Sudan
Duration: Current- August 31st, 2018
Closing Date: August 24th, 2018

Reporting to: The Technical Advisor, under the overall supervision of the Country Representative/Senior Technical Advisor and daily supervision of the Technical Advisor and/or Senior Program Officer.

Job Purpose: The Case Containment Center (CCC) Manager, provides Technical support to TCC-supported, MoH-GOSS South Sudan Guinea Worm Eradication Programme (SSGWEP). The position is based in a rural area and is a field-based position. Primary responsibilities of the position are to:

Key Responsibilities:

- Ensure GW patients are treated in accordance with the technical guidelines, and all GWD cases at the CCC are contained
- Live on-site and manage the Case Containment Center facility
- Ensure implementation of program technical guidelines
- Ensure all GW patients receive medical care and treatment
- Daily upkeep of the CCC and the stores.
- Facilitate daily participatory health education sessions, for all patients, family members and if they so choose, the community. Activities should include but are not limited to the following: Pipe filter bandaging, filtering contests, drama groups, local games, and focus group discussions. Supervise CCC Bandaging Assistant, cook (1), and Guards (2)- if required
- Ensure proper documentation for every patient treated at a CCC.
- Provide the responsible program staff one daily report via telephone; the report will include the number of newly arriving cases, village of detection, date worm emerged, and the number of patients released. The update should take place by 7pm every night.
- Attend the monthly Field Officer meeting.
- Manage and account for all SSGWEP monies and resources in a transparent and accurate fashion as per TCC financial management guidelines. Pay all CCC salaries.
- As needed, liaise with governmental and Non-governmental partners to achieve community-based health program objectives.

Person Specifications:

- South Sudanese National
- Fluency in English, Dinka, and Arabic
- Minimum qualification Degree or Diploma in Nursing or Public health preferred
- Work experience Minimum of 3 years, ability to maintain confidentiality of information
- Mature personality and portrays a greater sense of humour
- Strong community-based knowledge of surveillance system of the current area of coverage
- Willing to live and work in remote locations under basic conditions
