CALL FOR PRE-QUALIFICATION OF SUPPLIERS AND SERVICES PROVIDERS

Norwegian Church Aid is an International NGO implementing humanitarian aid programmes in South Sudan. We are updating our database of pre-selected/pre-qualified companies who will in future be invited to participate in tendering for supplies, services and works related to our activities.

Companies, consultants and contractors that offer any of the following: supplies, services and works, are being sought.

A. SUPPLIES

1. NON-FOOD ITEMS (NFIs) such as plastic sheeting, sleeping mats, blankets, cooking sets, jerry cans, mosquito nets, soap, Hygiene kits, fishing nets, hooks and fishing equipment.
2. WATER AND SANITATION (WASH) equipment such as India Mk II hand pumps, Electric supplies and switches and control gear, mechanical water pumping equipment, Emergency water storage and distribution equipment and supplies, (water bladders, HDPE pipes and fixtures, Gulliman clamps, etc), Electric Dewatering pumps, Submersible pumps, Surface pumps , Portable Petrol driven generators , Electric dip meters, Global positioning systems, Solar powered water pumping systems,, Afridev hand pumps, Water Quality consumables and reagents Water treatment equipment and chemicals

5. 4X4 VEHICLES and spare parts including supply and servicing.

- Operation Licenses
