1.0 BACKGROUND

The government of the Republic of South Sudan has received a Loan of UA1.25 million from the African Development Bank towards the cost of Non-Oil Revenue Mobilization and Accountability in South Sudan (NORMA-SS) Project under implementation by the Ministry of Finance and Planning of the Government of the Republic of South Sudan. It is intended that part of the proceeds of this loan will be applied to eligible payments under the contract for hiring international Consultant (Tax Lawyers). The estimated duration of these services is six (6) months and the expected commencement of the assignment is 01/07/2018.

1.2 MAIN OBJECTIVES OF THE CONSULTANCY:

The main objective of this assignment is to enable the government through the Ministry of Finance and Planning to embark on revenue modernization and tax policy reforms to boost non-oil revenue generation in a transparent and accountable manner.
