Who we are

In 2009, PSI started a Home Management of Malaria (HMM) program for children under five years old. Since then, HMM has evolved into a broader Integrated Community Case Management (ICCM) program with the addition of pneumonia, diarrhea and acute malnutrition interventions.

Responsibilities

The role of the Nutrition coordinator is to oversee all nutrition activities and provide leadership and management in coordination with the Interrelated Community Case Management (ICCM) Manager. He/she will work closely with the Nutrition Officer, ICCM team which includes M&E and ICCM Manager. He/she will be under the direct supervision guidance of ICCM manager, but is not limited to:

- Manage a remote team to effectively meet programme targets and objectives of the nutrition program within the ICCM structure
- Provide technical support to the nutrition team, ministry of health personnel and community volunteers responsible for the implementation of the Outpatient Therapeutic Program(OTP) services
- Provide technical inputs into DFID's proposals

- Responsible for the capacity building of the PSI and ministry of health nutrition staff and the community nutrition workers at the facility and community level
 - Contribute to the development and implementation of work plans and programmatic resource materials

 - Represent PSI in nutrition related activities and actively participate in nutrition key forums and meetings with all partners (Cluster meetings, health and nutrition technical working groups)
 - Perform any other related duties and activities that may be assigned by their supervisor
