# Child protection project Manager Assistant

Contract duration: 3 months (with possibility to be renewed)

### Key Activities/Responsibilities

- Ensure the day to day management of the Chid Friendly Spaces (CFS) in the area of operations
- Facilitate the identification of separated and unaccompanied children for support and referral
- Facilitate the provision of psychosocial support services to the most vulnerable
- Provide intensive support to staff in identifying, documenting, tracing and reunifying of UASC
- Provide cash management service to identified children including UASC.
- Establish and strengthen community based structures including parent support groups.
- Establish and empower adolescents groups to provide community-based PSS activities.
- Supervise and support structured psychosocial support, life-skill and recreational activities in the Child Friendly Space as per the work schedules set by line manager
- Ensure a safe and child-friendly atmosphere within the Child Friendly Space
- Manage and supervise the team of Community Animators and other CFS staff in the project locations to ensure roles and responsibilities are well-defined and fulfilled
- Ensure that children feel comfortable, motivated, safe, and respected in the Child Friendly Space
- Oversee outreach and adolescent activities to ensure high quality programming, high level of
- Actively participate and contribute to coordination meetings in the County;
- Ensure Tdh actively coordinates and contributes to the County's child protection and psychosocial
- Contribute to the establishment of effective community based referral and early warning systems;
- Enhance effective child protection networks at all levels and connect them as much as possible with regional and national child protection networks;
- Coordinate with other actors working in the same location and inform line manager on the latest development and any plans regarding to the project locations or the targeted population;
- Ensure that children feel comfortable, motivated, safe, and respected in school, income generating group and vocational training institutions;
- Support community mobilisation to increase understanding of children's needs and encourage community members to report child protection concerns;
- Oversee staff knowledge of, agreement to, and compliance with Tdh's Child Protection Policies;
- Build capacities for child protection through regular dialogue with local government partners and include
- Work closely with the DDR Project Manager and Child Protection Programme Coordinator to identify and address training needs of staff and community based structures;
- Conduct training, workshop and thematic exercise on Child Protection and PSS support as per needs
- Advise and contribute to program design on issues of sexual and gender-based violence.
- Collect field reports, check accuracy of data and combine reports on weekly and monthly basis for the





submission to the line manager;

- Prepare program reports for the DDR Project Manager on a weekly and monthly basis which includes quantitative and qualitative information on project accomplishments and impact;
- Contribute to the development of an effective system of monitoring and evaluation for child protection
- Inform line manager of challenges faced in doing the work, and if additional support is needed;
- Maintain the highest standards of confidentiality and ensure child safeguarding concerns are reported
- Establish synergies with other initiatives and projects to better respond to the needs of the target group; Perform other tasks as assigned by the line manager
