**All vehicles are sold in their present condition without warranty** and can be inspected at the ICRC's Juba Delegation on Ministries Road (just west of the Presidential Palace) from **Monday April 18th 2016 to Tuesday April 19th 2016 (between the hours of 9:00-12:00 and 14:00-16:00).**

- Ø Payment of customs duties and taxes remains the sole responsibility of the Buyer, and a cost the Buyer assumes over and above the bid submitted.
- Ø Bids are accepted in South Sudanese Pounds or USD only. Value of South Sudanese pounds will be calculated at current official bank rates. Payment to be made by bank transfer or certified check only.
- Ø A cash deposit of 500 USD is required in order to place a bid (2009 notes and newer only please). Unsuccessful bidders will be refunded their money, winning bidders will be credited the deposit.
- Ø Should winning bidders fail to make payment or decline the purchase the deposit will be retained by the Seller for breach of Contract.
- Ø Government formalities and tax related issues are to be finalized by the winners of the auction.
- Ø ICRC has the right to reject the sale partially or completely.
- Ø ICRC will not be liable for maintenance or spare parts upon sale of the vehicles.
- Ø Vehicles can be inspected and engine operated, but no test drives are allowed.
- Ø Bidders can submit their offer(s) for one or multiple vehicles.
- Ø The winner should finalize payment within a maximum of one week's time.
- Ø The winner should finalize duty payments and vehicle registration within a maximum of three weeks' time.
- Ø Vehicles will only be released to the winning bidder upon proof of duty payments AND proof of vehicle registration
- Ø ICRC will not be responsible for the delivery of auctioned vehicles.
- Ø Sealed bids will be opened on Tuesday April 19th 2016 at 16:30.

Offers must be submitted in person to the Fleet Manager's office, Logistics Department, Juba (see address at top) in sealed envelopes marked "Confidential – Vehicle Auction", before 16h00 on Tuesday April 19th 2016. Please clearly state the unit's auction number, your proposed bid price and telephone number in your offer. In case of identical offers, the earliest offer will be retained. Successful bidders will be contacted by no later than Friday April 22nd 2016. In the event any of the above deadlines are not respected, or contact is not possible, the concerned bidder(s) will be excluded from the bidding process. \*\*\*the ICRC reserves the right to cancel or amend conditions of the auction process without notice.
