## RE: Consultancy Services for the Process and Results Documentation of the Building Sustainable Future (BSF) Project

#### 1) Introduction

War Child Holland (WCH) is an independent and impartial international non-governmental organization investing in a peaceful future for children and young people affected by armed conflict. WCH works to enable adults and empower children and young people affected by armed conflict to bring about positive and lasting changes in their lives.

- 5. Valid Operation and/or Trading License (whichever is applicable)
- 6. Official Business physical, postal, telephone and email addresses
- 7. Proof of Business Insurance and workman's compensation or GPA (where applicable)
- 8. Reference and recommendations from at least 3 present or past clients
- 9. Child safety policy/ declaration against using child labour.( Important)

a) Individual consultants or firms who meet the minimum requirements shall submit 3 – 4 page proposal outlining their plan along with consultancy fee supported with budget breakdown in USD to War Child Holland – Juba office in a sealed envelope addressed to the selection committee not later than 22 June 2018.
