## **A. SPECIFICATION OF QUOTING**

**Objective of Request for Quotations:** In accordance with the overall targets of above mentioned operations, MI plans to order repair and service of Malteser International (MI) vehicles and motorbikes in Juba under the Framework Agreement.

### **2. Quotation Presentation**

The quotation shall be delivered in a sealed envelope to Malteser International - Country Coordination Office, Plot No: 445 Kololo Road 3k South, Tong Ping, Juba Town, South Sudan.

- The quotation shall be written in English
- The envelope must state the following information:

## 9. Content of quotation

## 11. Opening of submitted quotations

The quotations will be opened 8 April 2019 at 4:00pm in Malteser International Office in Juba, South Sudan, by the Procurement Committee. The selection process will be recorded in writing by the Procurement Committee.

## 12. Quotations evaluation

The criteria applied for the evaluation will be the legal conformity, the price, the technical experiences, the compliance with technical specifications and quality standards, and the capacity to deliver, delivery time and meet timeframes as specified.
