#### Roles and Responsibilities

- Conducting livelihood assessments including market analysis and institutional mapping
- Provision of home based assessment and support to PWD and victims of landmines/ERW.
- Work with the project manager with support from operational coordinator and technical advisor to develop relevant tools and systems for proper and effective implementation and monitoring of the livelihood activities
- Lead in the assessment and selection of beneficiaries for livelihood activities using relevant criteria.
- · Plan and implement relevant livelihood trainings to persons with disability in the target areas
- Travel to local communities to assess individuals with disabilities and families affected by landmines/ ERW using the PSS approach.
- Provide advice and coaching to victims of landmine/ERW and PWD on livelihood opportunities in the community
- Build and maintain strategic partnership with key stakeholders including the private sector, financial service
  providers and government stakeholders to facilitate referrals of persons with disability to access socioeconomic services and employment opportunities.
- Provide technical assistance to project team on livelihood for effective and result based implementation of the livelihood activities
- Coordinate and facilitate assessments, planning, budgeting, implementation, monitoring and evaluation of the livelihood activities
- Liaise with all relevant units to ensure a coordinated planning and implementation of the livelihood activities
- Identify key skill and knowledge gap related to livelihood and inclusion of persons with disability in livelihood service providers and address these through various capacity building initiatives

to stakeholders and/or partners

- Facilitate training or awareness raising to key stakeholders and support PWD to access locally available services
- Provide ongoing support to PWD and victims on IGA activities and to access services within their local community
- Provide practical support and guidance to other relevant stakeholders about how to adapt and include PWD in their activities.
- Represent HI in coordination events such as the FSL coordination meetings with stakeholders and partners.
- Document and record and report activities based on Hi monitoring tools.
- Any other duties as assigned by the line manager

- Ability to work without direct supervision and initiate activities with regular communication with supervisor.
