CALL FOR QUOTATION FOR MONEY TRANSFER SERVICES.

Back Ground:

Action Africa Help - International (AAH-I) is a nongovernmental Organization and nonprofit making operating in South Sudan with a mission to support disadvantaged Communities to sustainably improve their standard of living through Community empowerment approach in partnership with stake holders. AAH-I implements Primary Health Care (PHC), Agriculture, Humanitarian aid projects and Capacity Building.

The organization is calling for quotation from competent and reputable Companies for provision of money transfer services to the following areas:

TERMS OF SERVICES

- i. At the receipt of notification from AAH, arrange to transfer/deliver the advised and approved amount(s) to the named location(s); and claim for reimbursement from AAHI there after
- ii. Arrange to deliver the amount of money advised to the named destination within 48 hours from the date of notification;
- iii. Be able to deliver cash to all the geographic locations of AAHI operation mentioned in the list above.
- iv. Ensure that money delivered and received at the named location is acknowledged by senior Staff Member, in writing (signed cash delivery note);
- v. Submit proof and acknowledgement of delivery and receipt of the monies as per details;
- vi. AAH shall thereafter arrange to reimburse the service provider the confirmed transferred and received amount, plus the agreed service fee in respect of the transaction as per agreed contract terms.

vii. Payment in respect of this service shall be through either Bank Cheque or Direct Transfer within
7 days from the date of receipt of Invoice from the service provider. Payment shall only be made to the service provider's account named in the contract.

2. Eligibility and requirements:

2.1 Administrative requirements:

- 2.1.1 Valid certificate of incorporation as a business in South Sudan
- 2.1.2 Valid and Certified a True Copy of the Certificate of Registration as a CASH Transfer Service Provider in South Sudan, issued by the relevant authority
- 2.1.3 Valid and certified true copy of registration with the Tax Regulatory Authority of South Sudan (SS)
- 2.1.4 Copy of Articles & Memorandum of Association

2.2 Technical Requirements

- 2.2.1 Proof that the Service Provider has provided similar services to other Non-Governmental Organizations (NGOs)
- 2.2.2 Recommendations from reputable organizations operating in the Republic of South Sudan (RSS) for the similar services provided
- 2.2.3 Proof of having insurance cover for the said services
- 2.2.4 Service Provider's Banker's recommendation letter stating the financial capacity of the Service Provider during the last 18 months.

2.3 Financial Proposal (In US Dollars)

The financial proposal should be detailed, clear and must indicate any variables, unit prices and resulting total contract price. The proposal should be valid for 60 days from the date of opening of proposal advised in section 5 below.

3. Submission of Quotes:

The quotations shall be submitted in <u>Hard copies in sealed envelopes</u>, and there shall be no submission of quotes in soft copies.

Submission Address:

Registration for submission:

Please ensure that, you register your hand delivered quotation with the Procurement department and drop it in the bid box yourself, before you leave the Procurement department.

Request for clarifications:

Any request for clarification must be made in writing through the email: <u>procurement.southsudan@actionafricahelp.org</u> copy <u>bhillary@actionafricahelp.org</u>, Strictly and must be received not later than **Wednesday** the **31**st of **July 2017 at 4:00 pm local time.**

4. Price and Currency:

The prices shall be in United States Dollars (USD).

5. Dead line for the submission of the quotation:

The deadline for the submission of the quotes will be strictly on **Monday** the 4th August, **2017** at

12:00 pm local time.

6. Notification of the results:

Only the successful and competitive bidder will be notified, and if you do not receive email communication within two weeks after the expiring of the dead line, consider your bids not successful.

7. Award of the Contract & Bid validity:

The Contract agreement shall be awarded to the selected bidder not later than **15**th **August, 2017** and your bid should remain valid until that day.

Language for the bids:

The language for the bids shall be **<u>English</u>** only, no other languages to be used.

8. Selection Criteria

ONLY companies that fully and satisfactorily meet the requirements listed in **Section 2** above (*Mandatory information and documentation*), the Vendor Prequalification Form and any other criteria which the Procurement Review Committee shall deem necessary for this purpose, shall be pre-qualified and shall be invited to participate in the subsequent bidding process.

8.1 Evaluation of proposals:

A Comprehensive Criteria will be followed in evaluating the proposals submitted in accordance with the guidelines prescribed above. The criteria will follow a weighting system advised below:

i-	Administrative Compliance	10 points
ii-	Technical Compliance	70 points
iii-	Financial Proposal	20 points

Important Notes:

- i- The bidder's proposal **MUST** obtain all the 10 points under the Administrative Compliance Stage and a minimum of 42 points from the Technical Compliance Stage to qualify for the Financial Evaluation Stage. Accordingly, any bidder whose proposal fails to obtain all the 10 points under the Administrative Compliance Stage, will not be considered for Technical Evaluation.
- ii- The score for the bidder's Financial Proposal will be arrived at using the following formula:

P = 20 x (u/z)

- P: Financial Score
- U: Price of Lowest Compliant Bid

Z: Price of Bid being evaluated

Award of Contract:

The Contract will be awarded to the Bidder who scores the highest total marks from the evaluation process detailed in 8.1 above.
