Tasks & responsibilities	 Provide technical support on medical aspects of these programs to ACF Nutrition Program Managers Provide technical support to ensure high quality care for beneficiaries of ACF nutrition sites. In particular the candidate is expected to: ensure correct diagnosis / treatment of medical complications associated to SAM and correct general management of SAM inpatient children in SCs according to national and ACF guidelines, ensure correct medical consultation and referral at OTP level
	 Improve, develop, and follow up on application of guidelines for SCs treatment of patients, admission and referral procedures and documentation Improve the management of the pharmacy, regularly developing inventory and stock reports, and other actions necessary for ensuring a good stock management.

Tasks & responsibilities	 Participate at the identification of ACF nutrition teams' training needs on the basis of assessments and direct observation Prepare/Review the medical team training package Train the medical team in order to reinforce its competencies in management of acute malnutrition according to needs identified Prepare documents and briefs to guide treatment of medical complications in SC Train the newly recruited medical staff on management of acute malnutrition, especially the medical component, in collaboration with Nutrition PMs Build capacity of the ACF medical team on monitoring and reporting indicators, and pharmacy / supply management Daily supportive supervision of medical activities and on the job training for medical staff in OTP/SC
