Objective

Key Responsibilities:

- 1. Undertake all assessment, diagnosis, care, treatment and follow up of all inpatients.
- 2. Conduct Ward Round and maintain treatment as per CO's/ In-charge's instructions
- 3. Maintain the highest standard of care and cleanness in the facility.
- 4. Perform all nursing procedures (NGT, Catheterization, cannulation, injection both IM and IV) to required MoH standard to ensure NO HARM is done to the patient/client
- 5. Represent CCM and County Health Department/Ministry of Health as may be required
- 6. Maintain, update and ensure proper filling of government HMIS tools and other data registers.
- 7. Support timely weekly and monthly epidemiological reports using prescribed forms.
- 8. To carry out additional responsibilities as assigned by Clinical officers In-charge.
- 9. Manage all types of wound dressing using accepted universal aseptic technics
- 10. Conduct and manage all the shifts (morning, noon and night shift) of duty roster setup at the health facility accordingly
- 11. Support monitoring of drugs and other medical supplies requisition, consumption and control that fall under his/her duty
- 12. Support ANC and safe/clean deliveries services in the absence of midwife and or maternal and neonatal health worker
- 13. Prepare bed for patients
