- 1. Cmmb hereby solicit your bid for supply and delivery of medical supply for cmmb Office Yambio.
- 2. To enable you to submit a bid, please find enclosed:

- 3. Bids in sealed envelopes must be delivered in sealed Hardcopy envelopes only and should reach the following address: Office of safety and Security at Yambio Office or to John Data cmmb Office in Juba no later than 19th-July-2018 at 15:00 hours
- 4. Your submission will be considered upon the provision with the following, failure in providing the requested documents may grounds for disqualification of the bidders:
 - > Company Profile with description of similar experience
 - Reference list with detail of previous contracts in the same business field with description and amount
 - > Financial Details and information to demonstrate a sound financial standing



- Offerors must have a valid trade license and produce evidence of stock availability, warehouse facility and well-defined business address.
- 5. After receipt of bid, cmmb reserve the right to request any additional information or seek clarifications from the bidder to ascertain responsiveness of offers received.

a. Instruction to Bidders

- General: cmmb invites sealed Bids for supply of Medical supplies and delivery to Yambio Office
- II. **Eligible Bidders:** Bidders should not be associated, or have been associated in the past directly or indirectly with cmmb in the preparation of the design specifications of the procurement of goods to be purchase under this invitation to bid.
- III. Cost of bid: The bidder shall bear all the cost associated with the preparation and submission of the Bid, and cmmb will in no case be responsible or liable for those costs.

b. Solicitation Documents

- Examination of solicitation Documents: The bidder is expected to examine all
 corresponding instructions, forms, terms and specification contained in the
 solicitation Documents. Failure to comply with these documents will be at the
 Bidder's risk and may affect the evaluation of the Bid
- II. Clarification of solicitation Documents: From the date of receipt of this bid until instructed otherwise, all written or verbal communications by the Bidder with cmmb should be directed to the designed Officer.
- c. Documents comprising the Bid: The Bidder or Bidders' authorized agent shall sign the Bid.

The Bid must comprise the following documents:

- A Bid submission form
- II. A price Schedule completed in accordance with price schedule sheet.
- III. Documentary evidence established in accordance with Instruction to Bidders that the Bidder is eligible and qualify to perform the contract if its Bid is accepted.
- d. **Bid currency/Bid prices:** All prices must be quoted in **USD/SSP**. The bidder shall indicate on the appropriate price schedule and total Bid price of goods it proposes to supply under the contract.
- e. **Submission of Bids:** The bidder shall prepare one original copy and seal in an envelope and submit to our Office in Yambio or Juba.
- f. Deadline for submission of Bids: (a) Bid must be delivered to the Office on or before the date and time specified in the Letter of Invitation of these solicitation Documents.



- (b) Cmmb may Extend at its discretion, extend this deadline for submission of the Bids by amending the Bidding Documents.
- (c) Any Bid received by **Cmmb** after the Deadline for submission of Bids will be rejected and returned unopened to the Bidder.
- (d) Samples: Samples of items, when required, must be provided within the time specified unless otherwise specified by cmmb.

g. Opening and Evaluation of Bids.

- (a) **Opening of Bids**: Cmmb will open bids in the presence of Bidders Representative who choose to attend at the time, on 20th-July-2018 at Yambio Office.
- (b) Clarification of Bids: To assist in the Examination, Evaluation and comparison of Bids, cmmb may at its discretion ask the Bidder for clarification of its Bid. The request for clarification and response shall be in writing and no change in price or substance of the Bid shall be sought, Offered or permitted.

h. Preliminary Examination:

- (I) Prior to the detailed evaluation, cmmb will determine the substantial responsiveness of each Bid to the invitation to Bid.
- (II) Cmmb will examine the Bids to determine whether they are complete, whether any computation errors have been made
- i. **Evaluation of Bids**: cmmb will evaluate and compare the Bids which have been determined to be substantially responsive pursuant.

j. Award of Contract:

Cmmb will issue the Purchase Order or Contract to the lowest priced technically qualified Bidder. Cmmb reserves the right to accept or reject any Bid any time prior to award of purchase Order.

k. Payment.

Payment will be affected 30 days after receipt of invoice, proof of dispatch and other supporting Documents. It is not policy of cmmb to approve advance pay.

Currency of payment: Payment will be made in the currency in which the Purchase order is issued.

I. Technical Requirements

Bidders are required to provide all the data as per the following requirements. Failure to provide any or part of the items thereof may result in the Bid being rejected.
