Expertise in reproductive health, family planning and/or social/behavior change communications.

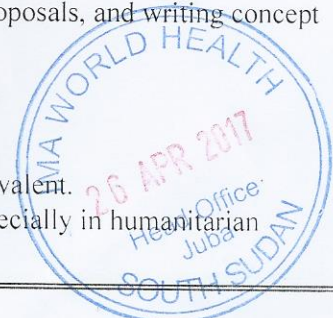
The Reproductive Health Advisor will provide overall technical leadership for IMA's reproductive health programs in South Sudan. S/he will implement and oversee reproductive health programs which aim to strengthen the availability and use of family planning, skilled attendance during labor/delivery, and increase uptake of antenatal and postnatal care. The position will be based in Juba, South Sudan with frequent travel to the field.

RESPONSIBILITIES:

- Manage all aspects of IMA's reproductive health programs including recruitment, supervision and capacity building of all RH staff;
- Develop detailed program implementation and monitoring plans and adapt programs to changing context as needed;
- Develop capacity of the local implementing partners in technical knowledge, skills and program management;
- Conduct site visits regularly to monitor and supervise the program to ensure quality of services, accurate data collection and verify stock levels of pharmaceuticals and supplies;
- Ensure that all donor required activities, indicators and objectives are successfully met within the project timeframe;
- Author program deliverables and assure that they are submitted in a timely manner; Synthesize and disseminate lessons learned, innovations and best practices;
- Work with finance, logistics, HR/admin and security to ensure smooth implementation of project activities;
- Attend coordination meetings and work closely with other partners in RH to help ensure access to the services and avoid duplication of efforts;
- Contribute to new business development including leading technical designs of proposals, and writing concept papers;
- Perform other duties as assigned.

EDUCATION, EXPERIENCE & CERTIFICATIONS:

- Clinical degree, nurse or midwife preferred, with a Master of Public health or equivalent.
- A minimum of five years' experience in public health in developing countries, especially in humanitarian setting.



- Specialization in reproductive health, family planning or maternal and child health
- Five or more years' experience as senior clinical /technical expert and as thought-leader in FP and MCH field.
- Experience managing USG-funded projects in RH/FP and MCH areas in developing countries.
