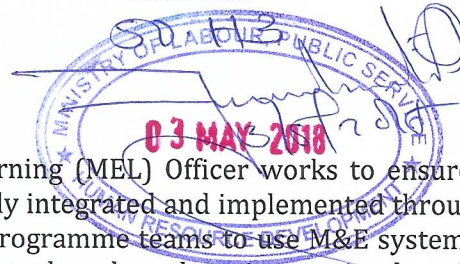
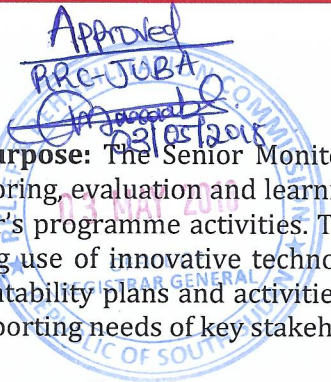

Senior Monitoring, Evaluation and Learning Officer



Job Purpose: The Senior Monitoring, Evaluation and Learning (MEL) Officer works to ensure that monitoring, evaluation and learning systems are consistently integrated and implemented throughout Medair's programme activities. This involves: supporting programme teams to use M&E systems and making use of innovative technology, to collect, aggregate and analyse data; integrating beneficiary accountability plans and activities into Medair's programmes; and playing a key role in ensuring that the reporting needs of key stakeholders are met.

Key Responsibilities

Monitoring and Evaluation

- Design and implement, in collaboration with field sector advisors and the MEL manager, data collection such as needs assessments, Post Distribution Monitoring, SMART and KPC surveys using recognised methods of data collection (e.g. cluster sampling, LQAS).
- Train relevant programme staff on M&E tools, data collection and analysis, and basic surveying and sampling techniques.
- Ensure the collection of good quality data in order to reflect the progress of programming by supervising enumerator teams, data clerks and translator teams.

Beneficiary Accountability

- Promote the principles and practices of beneficiary accountability to colleagues by providing support in beneficiary feedback and other good practices as required

Communications

- Provide, in collaboration with the MEL manager and with input from field and HQ sector advisors, support for project managers, in projecting data, and compiling reports on progress towards indicators
- Provide analysis of data in a timely manner for internal monitoring and donor reporting, writing project reports as required

Quality Management

- Coordinate the technical aspects of field M&E operations such as mapping the survey area and asking for the latest population data
- Actively participate in designing questionnaires for surveys and assessments
- Coordinate the logistics involved in survey related field work: following up with the project teams on enumerator recruitment progress and booking a training venue
- Coordinate the translation and back translation of questionnaires and other data collection tools.

Delegated Responsibilities

- Collaborate with the project managers, field and HQ advisors during planning and preparation for Household Surveys (Baseline, follow up/mid-term, end of project)
- Ensure smooth and timely flow of information from survey preparations, implementation, results sharing and report writing
- Design enumerator training material for implementing household and other surveys as required
- Train project field team members on M&E and survey methodologies such as LQAS and cluster sampling as part of staff capacity building
- Analyze group dynamics among the enumerators and monitor the teams during field work
- Being responsible for advising and supervising the enumerators, reviewing the completed questionnaires and ensuring data quality
- Oversee data entry process by designing data entry templates and supervise the work of the data clerk(s) during data entry
- Analyze, present data as well as communicate survey/ assessment findings with responsible
