Background

AAH South Sudan is a country programme of Action Africa Help International (AAH-I), an African-led, not for profit humanitarian and development headquartered in Nairobi, Kenya. AAH South Sudan supports livelihood-challenged communities to sustainably improve their well-being and standard of living. AAH-I in partnership with UNHCR is supporting refugee communities in Gorom refugee camp (25km outside Juba) with livelihoods recovery interventions. The interventions aim to build refugee self-reliance and enables refugees to depend less on hand-outs. One of the key interventions AAH-I is implementing in Gorom is promotion of appropriate and diversified agricultural systems where a small irrigation scheme was established to enable diversified and all year round agriculture production. However, since establishment, the irrigation system has not been fully functional. As such, AAH-I is seeking an irrigation specialist to reassess the system and make necessary modifications for the system to fully function.

The organization is calling for quotation from competent and reputable Companies for supply of labour and materials for construction of gravity fed water ponds as per specifications given below:

6 Shallow wells

They will be supplied by a telescopic piping system of 63mm reducing to 50mm polyethylene pipes of class B at the lower ends. The wells will have a depth of 80 cm holding a volume of 2,000 liters each when full. The 80cm depth is designed to reduce chances of drawing by the users or children and small stocks. The wells are spaced at 40m from each other a design aimed to serve 1,600 square meters per well just over one quarter of an acre.
