#### **JOB PURPOSE**

- She/he will be specialist in training farmers in Ox plough farming, supporting in setting up large scale farming. Training farmer groups on Ox plough management, business management and marketing. With support from the agricultural Project officer and the FSL team, she/he will participate in development of training materials, planning and delivery of trainings.

#### **OBJECTIVES**

 To support in imparting skills and knowledge to communities in best farming method/practices through trainings and result-based experiments to improve household food production.

### **Duties / responsibilities**

- To work closely with Agriculture Project officer and other FSL team members in building the capacity of farmer groups and pastoralist communities through introduction of new techniques of Ox plough farming to increase productivity
- To be the lead in technical demonstration of Ox plough farming and offering hands on demonstration to agro pastoralists.
- Ensure effective organization of trainings and participatory discussion with farmer groups on the methodology;
- Training farmers on the correct methods on the various stages of Ox plough implementation.
- Support, and evaluation of Ox plough activities in demonstration farms as required by the project;
- Training farmers on the Ox plough management, Business management and marketing
- Participate in community sensitization of any community activities related to food security and livelihoods
- Supervising the Ox plough activities in demonstration plots, offering technical guidance and reporting.
- Motivating, mobilizing and involving agro pastoralist in every stage of Ox plough training;
