

## **EXPRESSION OF INTEREST TO SUPPLY PHARMACEUTICALS, MEDICAL CONSUMABLES AND MEDICAL EQUIPMENT**

**International Medical Corps (IMC)** is a global, humanitarian, non-profit organization dedicated to saving lives and relieving suffering through health care training and relief and development programs. Established in 1984 by volunteer doctors and nurses, International Medical Corps is a private, voluntary, non-political, non-sectarian organization. Its mission is to improve the quality of life through health interventions and related activities that build local capacity in underserved communities worldwide. By offering training and health care to local populations and medical assistance to people at highest risk, and with the flexibility to respond rapidly to emergency situations, International Medical Corps rehabilitates devastated health care systems and helps bring them back to self-reliance.

Hence, IMC in South Sudan is hereby inviting legally registered, competent, professional and well established Vendors and/or Service providers capable of supplying and providing IMC within South Sudan to express their interest in the following;

- i. **Pharmaceuticals (PHAR001),**
- ii. **Medical Consumables (MEDC002)**
- iii. **Medical Equipment (MEDE003)**

The expression of interest is for purposes of **prequalification** of vendor-suppliers so as to establish long term supply and service relationship (contracts) with Companies that will be successful.

**The Process: -**

1. Interested parties; companies should send an email with **company profile**, registration certificates with South Sudan Drug and Food Control Authority (**License B**) to International Medical Corps emails below indicating that you are willing to participate in the prequalification exercise/process, which is to be launched soon after the closing date of EOI.

**You must clearly indicate which category and/or categories out of the 3 categories mentioned above you would like to participate by providing particular EOI Reference Number(s) as indicated above.**

4. Registration is **Mandatory** part of EOI for those not yet registered in the IMC Vendor catalogue, as it is mandatory for any vendor to be prequalified to have been registered. After review of your profile and if it matches the set expectations, at the sole International Medical Corps' discretion, you may be invited to participate in the prequalification exercise.
