BACKGROUND:

The International Rescue Committee (IRC) responds to the world's worst humanitarian crises and helps people to survive and rebuild their lives. Founded in 1933 at the request of Albert Einstein, the IRC offers lifesaving care and life-changing assistance to refugees forced to flee from war or disaster. At work today in over 40 countries and 22 U.S. cities, we restore safety, dignity, and hope to millions who are uprooted and struggling to endure. The IRC leads the way from harm to home. IRC has operated in South Sudan for over 30 years now delivering humanitarian relief, post-conflict assistance, and development programs in both refugees, internally displaced, and host community settings. IRC operates in 9 field offices including in Juba with a program portfolio covering health, nutrition, child protection, economic recovery and development (ERD)/livelihoods, women's protection and empowerment, and general protection. IRC continues to provide life-saving assistance and humanitarian aid to vulnerable South Sudanese, trying to rebuild their lives and restore peace. The IRC's new strategy in South Sudan will prioritize improving health, safety, and economic wellbeing, targeting women, children, and other vulnerable groups.

The IRC South Sudan is currently implementation comprehensive programming in Bentiu and Rubkona County in 2021. The current population to be served by the IRC's Environmental Health/WASH program in the host community is 12,000 people. The Water and Sanitation (WATSAN) officer will be responsible for ensuring quality and smooth implementation of WATSANT construction/rehabilitation as well as any other relevant components of the IRC's Environmental Health/WASH program in the targeted communities. She/he will provide leadership and guidance to the program assistants under her/his supervision. The Environmental Health/WASH program will focus on the provision of adequate and safe water supply through boreholes rehabilitation and water quality assurance, safe sanitation facilities, and the promotion of safe hygiene practices in averting diarrheal disease risk factors. The position will be based in Bentiu town with frequent travel to the targeted host communities around Bentiu and Rubkona County.

Under the supervision of the WASH manager, the Environmental health/Sanitation Officer will be involved in planning, implementation, management, monitoring, and evaluation of the implementation of sanitation infrastructures and capacity building of staff and volunteers in the communities to promote good sanitation and hygiene practices. She/He is responsible for the construction of sanitation facilities and management of field team, intensive training, and mentoring skills, and working in coordination with the other Water supply and Sanitation officers. The position requires strong sanitation facilities designing skills, construction

Key Responsibilities:

- Assist the WASH manager to develop all the necessary designs, technical drawings, bills of quantities, and specifications for the water and sanitation projects in the targeted health facilities, Nutrition outreach, and host communities. Also, prepare follow-up schedules to water and sanitation projects implemented throughout the construction phase and ensure that designs specifications are followed during construction by the construction technicians.
- Work closely with the health officials and host community leadership to identify targeted health facilities and Nutrition outreach, and identify targeted host communities as well as households
- Support the EH WASH manager and ensure that the targets for Water and Sanitation project are professionally implemented and completed to meet the IRC, WASH cluster, and donor standard within the project period

- Supervise all outsourced construction activities for Environmental Health/Sanitation facilities construction and ensure the design and constructed facilities meet the donor and IRC standards.
- Draft and share weekly reports for the water and sanitation component with the WASH Manager.
- · Act as the focal person for all IRC WATSAN activities in Bentiu and Rubkona County, participate in meetings regarding Environmental Health/WASH activities in the host communities as advised by
