Job Purpose:

This position will be responsible for overseeing technical aspects of Concern's WASH programming in Unity State, whilst ensuring compliance with humanitarian standards and delivering high quality WASH outputs in accordance with programme plans and budgets. This shall be done in collaboration/consultation with WASH PM, WASH Advisor, Deputy Program Director, PQ unit and Area Coordinator. Key activities include providing technical oversight and quality control in the design, implementation, monitoring and evaluation of hardware component, training and on-the-job coaching of staff, ensuring programme is delivering as per international and Concern emergency standards, supporting procurement matters for programme implementation.
