## Section 11: Tender Guidelines/Regulations and Criteria

#### i. Incomplete Application

The application forms that are not filled out, duly stamped, and submitted in the prescribed manner will not be considered by the reviewing committee mandated to carry out this exercise.

#### ii. The Tender Data

It is understood and agreed that CDoM will use the prospective Supplier's tender data to select a prospective Supplier to perform the contract regarding items as described by the client in clause 2 of this document.

#### iii. Tender Requirements

Prospective Suppliers will not be considered qualified unless, in the judgment of CDoM, they possess the capability, experience, qualified personnel, available and sustainable equipment, and net current assets or working capital enough to execute the contract for goods satisfactorily.

## Section 12: Essential Criteria for Tender

#### i. Experience

A selection committee of qualified staff will evaluate all offers and select the best supplier based on price, quality, previous experience with the company, and delivery capacities.





The prospective bidder shall have at least one (1) years' experience in the supply of similar goods. Past performance will be shown by attaching relevant local purchase orders (LPO)/contract agreements and letters of recommendation. Suppliers should further specify the area of specialization.

Prospective suppliers should have exceptional experience and capability to organize, supply, and deliver items at short notice.

Quotations will be evaluated according to the following criteria:

CDoM has the right to reject the tender from a selected firm, should a condition arise between the time the firm has tendered and the bid opening date which in the opinion of the CDoM could compromise the performance and but not limited to bankruptcy, change in ownership or new commitment.
