## **County Health Coordinator**

#### Job summary

The County Health Coordinator is responsible for the on-the-ground implementation of project plans as outlined by the Program Director/HSTP Project Manager while co-locating with the county Health Department Director. This includes coordinating field activities, managing field staff (MEAL officer, Medical logistician, BHI officer and any other staff who would be deployed to the field) and volunteers, ensuring compliance with project timelines and budgets, and engaging with community stakeholders. The County Health Coordinator will play a critical role in translating project objectives into tangible outcomes and ensuring that all activities are executed efficiently and effectively.

## **Duties and Responsibilities**

Field Operations Management

Coordinate and oversee daily field activities to ensure adherence to the project plan.

- Supervise and support field staff and volunteers, providing guidance and resolving any issues that arise on-site.
- As the primary custodian of all COSEDA assets, ensure all assets are safe and active inventory maintained.
- Take lead in all emerging health issues within the county that fall within the purview of health.

Community Engagement

 Engage with community members and local leaders to foster COSEDA acceptance in the area of operation, strong relationships.

ensure community participation and support for project activities.

 Address community concerns and feedback, adjusting project activities as necessary to meet prevailing community needs.

Monitoring and Reporting

Monitor the progress of field activities against the project plan, identifying and addressing any deviations or delays.

Share input for proposal development and areas that may need interventions.
 Collect and analyze data from the field to track project performance and outcomes.

 Prepare regular reports on field activities, progress, and challenges for the Project Manager.

Resource Management

- Manage the allocation and use of resources in the field, ensuring that materials and equipment are used efficiently.
