BACKGROUND

Job Title:

IsraAID is an Israel-based non-governmental organization that was founded in 2001 and has since its inception worked in emergency and long-term development settings in over 55 countries. IsraAID's mission is to support people affected by humanitarian crises by partnering with local communities around the world to provide urgent aid, assist recovery, and reduce the risk of future disasters.

We are therefore seeking for experienced, self-motivated, a highly competent individual with exemplary ethical conduct to join our South Sudan Program as a Community Facilitator to be based in Juba.

JOB PURPOSE

Under the direct supervision of the Project Officer, the Community Facilitator implements the social mobilization activities as stipulated in the ISRAAID Project requirements and Standards. S/He will conduct evidence-based advocacy for effective and efficient program facilitation of Protection interventions (General Protection, Child Protection, Environmental awareness and GBV).

KEY RESPONSIBILITIES:

- Responsible for community mobilization and engagements and for coordinating activities at the community and the school with understanding of the local context with positive community interactions.
- o Conduct information and awareness sessions with women, girls, men and boys in the community to disseminate information about available services and key protection concerns;
- Identify and assess new communities to be engaged in GBV activities;
- o Maintain regular contact with community leaders and school administration to ensure a constant flow of information and feedback:
- Identify and engage key "gatekeepers" within the community and the school to ensure access of project team and promote participation of the community in activities;
- o Facilitate and monitor the implementation of planned activities and community and school level engagements:





- Mobilize and facilitate the engagements of stakeholders during planning and development meetings, workshops and seminars;
- o Identify local level partners, support and facilitate the partnership in the implementation of planned activities;
- o Facilitate stakeholders and partners in supervision and monitoring of programmatic activities;
- Support the collection and documentation of impact and success stories on monthly, quarterly, semiannual and annually;
- o Documentation of evidence-based impact stories.
- o Performs any other duties
- In collaboration with Social Workers and the project officers, sensitize community empowerment through TEAM approach by organizing peer facilitators and formation of community engagement activities;
- Mobilize and facilitate active participation of women and children and their communities to participate in planning, monitoring and implementation and evaluation of community development initiatives;
- Build the capacity of children, families and community to collectively engage local leaders on identified issues;
