The WASH Officer will play a pivotal role in supporting the Community Action Organization (CAO) by collaborating closely with government agencies to assess the needs of vulnerable populations in the designated project areas. This role will encompass a range of responsibilities, including WASH contingency planning and preparedness initiatives, as well as the assessment and formulation of a comprehensive, trainings and capacity building, long-term WASH strategy coupled with actionable operational plans.

Key aspects of this position involve fostering coordination with sub-national WASH partners while working in sync with state authorities. The WASH Officer will also be responsible for monitoring the implementation of WASH projects, ensuring that each site meets the required levels of WASH services. This will be done in accordance with the CAO's established WASH Manual and Technical Guidelines, as well as adhering to the applicable WASH cluster standards and national regulations. Through these efforts, the WASH Officer will help guarantee that vulnerable communities receive the critical water, sanitation, and hygiene services they need to improve their health and well-being.

Roles and Responsibilities

Leadership and Coordination

- Lead the delivery of WASH services for vulnerable at risk communities to meet the CAO's standards and / or the national WASH standards, depending on the context.
- Act as a focal point for WASH issues within CAO at field level and liaise with NRC, UN
 and international agencies, Government and Non-governmental counterparts.

WASH Strategy, Planning and Programme Support

- Actively participate in drafting WASH strategies, and operational plans for CAO's WASH programme at the country level.
- Jointly with technical staff of implementing partners and other WASH actors, update detailed needs and resource assessments and revise designs of technical plans as necessary, taking into account practical aspects of implementation, long-term and relevant technical specifications and guidelines.
- Advise and assist the CAOs WASH staff at headquarter on the development of WASH aspects of the programme including planning, budgeting and input to financial management of the programme.

Technical Assistance and Capacity Building

- Provide technical guidance and support to partners on all water, sanitation, hygiene promotion related issues, to ensure quality, cost-effectiveness, sustainability and impact soundness in their implementation and in accordance with CAO's policies, standards and priorities.
- Facilitate capacity strengthening activities of national CAO WASH staff and, if applicable, of staff of implementing/operational partners to address key areas of WASH importance to refugees and other persons of concern to CAO.

Monitoring, Evaluation and Quality Assurance

- Supervise and monitor the implementation of the ongoing water, sanitation, hygiene projects administered directly by CAO and its partners.
- Ensure that mechanisms to monitor the performance of CAOs WASH activities in the IDP, Returnee camps / settlements, and host community sites.
- Ensure that the WASH Monitoring System data collection and reporting is carried out systematically, properly and timely with quality information

Reporting

- Report regularly on WASH activity implementation to subnational cluster, and line manager while maintaining accurate records of all relevant WASH performance indicators.
- Prepare regular sectorial reports and submit material for preparation of periodic project monitoring reports as required by the office at country level.
- Maintaining regular contact with the WASH Unit, in Juba regarding all technical matters.
