DESCRIPTION:

The United Nations World Food Programme in South Sudan (WFP South Sudan) invites interested and competent companies with proven track record of relevant experience to submit their Expression of Interest for the provision of the following services.

PARTICIPANTS AND ELIGIBILITY CRITERIA.

This Invitation for Expression of Interest is announced for all qualified companies in any of the services stated below and legally registered in South Sudan.

- 1) **Fumigation and pest control services** at WFP/CP warehouses throughout the country. Services include fumigation and spraying of food commodities to control insects, rodents, and termites in WFP/CP warehouses.
- 2) Provision of **Road Transport- All Terrain Trucks (Specialised trucks) 6x6 and 8x8 wheel drive.**
- 3) Provision of **Multi-Modal Transport services** in South Sudan (A Transport contract that involves both River and Road Transport)
- 4) Provision of **River boat transport services** along the Nile River
- 5) Provision of **River barge transport services** along the Nile River
- 6) Provision of **River Speed Boat** transport services along the Nile River
- 7) **Warehousing facilities with offices** within the premises, a perimeter wall and in a good location in Juba.
- 8) **Primary Road Transport Ex Juba** to various locations in South Sudan

- Bank statement of accounts certified by the bank.
- Copies of the company's business registration certificates and required licenses to operate in South Sudan. (Certificate of Incorporation, Certificate from Chamber of Commerce, Tax Registration Certificate, Tax Clearance Certificate, Operation license from respective State Authorities)
- Provide information on company's experience in this type of activity. WFP require at least 3 copies of reference letters from companies / organization your company provided and / or is providing similar service.
- For primary road transport provide the list of trucks with copies of their Logbooks (**Only Trucks in South Sudan**)

Specific Documents required for the below Additional services.

1. **All Terrain Trucks (Specialized) 6x6, 8x8**
The company must Provide the list of trucks owned by the company and copies of their logbooks and transport license issued by Ministry of Transport, Directorate of Road Transport
2. **FUMIGATION SERVICES (Additional Documents Required)**
Fumigation to provide license from ministry of Agriculture & Environment and approved list of fumigators.
3. **Multi-Modal Transport services**
To provide list of trucks & boats and copy of shipping licenses for the boats and logbooks of the trucks.
4. **RIVER TRANSPORT SERVICES (Boat, Barge & Speedboat)**
Provide shipping License for navigating on the Nile.
