1. Background of the FCA operational context in South Sudan

South Sudan attained independence from Sudan on July 09, 2011, after a referendum, becoming the newest country in the world. The oil-rich country faced an enormous setback with the civil war which began in December 2013. This conflict has resulted in a substantial loss of lives and the displacement of over 2.3 million people from their homes. Currently, 1.7 million people have been displaced from their homes while 640, 000 live in neighboring countries as refugees. Besides, there are almost 200,000 IDPs currently being hosted at the UN Protection of Civilian (POC) sites in Juba, Bentiu, Melut, Malakal, and Bor. The conflict has also resulted in massive destruction of property and infrastructure. International communities, including the Inter-Governmental Authority for Development (IGAD), has made a significant attempt to support the warring parties to reach a peaceful agreement and restore stability in the country. The R-ARCSS that was signed in September 2018 in Addis Ababa rejuvenated hope among the people of South Sudan. The formation of the Transitional Government of National Unity in November 2019 is expected to take place as planned to materialize the peace agreements signed among the parties.

FCA implements the Right to Peace, Right to Livelihoods, and Right to quality education in the country.

In terms of peacebuilding work, FCA has been supporting the facilitation of community-level peace processes, conducting capacity building in peacebuilding and conflict transformation processes, developing skills of the target population in dealing with conflicts effectively and non-violently.

To streamline and enhance its work in peacebuilding and conflict transformation at the community level, FCA intends to develop an integrated resource pack. The training material targets the youth, women, traditional chiefs, interchurch committees, and peace actors at the target locations where FCA is operational.

2. Rational, purpose and priority objectives of the resource pack development for conflict transformation and peacebuilding

The purpose of an integrated resource pack (peacebuilding and conflict transformation) development is to have a standardized training material that is tailored to the needs of the target population (youth, women, traditional leaders, people of faith and duty bearers). The resource pack will be designed in a way that ensures the development of capacities and skills needed to transform the conflict in the area where FCA operates.

FCA and peace actors will use the standardized resource pack in South Sudan in community conflict transformation processes.



3. Scope of the assignment

The resource pack includes the following key modules

- Module I: Conflict early warning and rapid response systems
- Module II: Conflict prevention and management, transformation processes, and skills.
- Module III: cross-cutting issues and conflict (Gender, Climate change, Environment, and Conflict)
- Module IV: Youth, women, Entrepreneurship and Sustainable Peace
- Supplementary module: Trainer's facilitation guide.

The content of each module should include but not limited to, the following:

- Introduction
- The objectives and learning outcomes for each module and session.
- Key concepts that should be covered in each module.
- The modules are divided into manageable lessons/ sessions.
- Practical context-specific examples, role plays, and exercises for each lesson/session and
- Training Facilitation/ learning guide for each lesson
- Checklist for planning each session

4. The methodology required & available data

In line with FCA's right based approach, the consultant will conduct consultations with the target users of the resource pack and carry out desk review on existing secondary sources outlined in the modules section. Specifically:

- The consultant will conduct desk-review on the existing community-level peacebuilding and conflict transformation, and the above-mentioned module topics, training materials, and approaches.
- Conduct local community level consultations with women, youth, interfaith groups, and traditional leaders on the best approaches for training in the modules mentioned above and translate the consultation outcomes into curriculum design.
- Develop target beneficiaries tailored training resource pack as outlined in section 3 above. The module should be developed taking into consideration adult learning methodology (experiential learning) which is more of the practical method with classroom exercises, participatory reflections, and practical examples.
- Plagiarism should be avoided 100% and the consultant should acknowledge all sources used in the resource pack development.

5. Deliverables and timeframe Deliverables

- An inception report on how to approach the development of an integrated Peacebuilding and Conflict transformation resource pack.
- Develop a draft integrated peacebuilding and conflict transformation resource pack after consulting the target communities in the field.
- Conduct a one-day validation workshop on the resource pack with key stakeholders.
- Deliver a 4-5 days Training of Trainers level training on the resources pack for selected community level trainers.
- Revise and submit the final resource pack on an Integrated Peacebuilding and Conflict Transformation after incorporating the inputs from the validation workshop and ToT level training.
- Develop a checklist for planning training on each module.

• A minimum of 10 years of relevant experience in local-level capacity development in peacebuilding and conflict transformation, conflict analysis, negotiation and mediation, and dialogue facilitation skills.

C. Competencies:

- Demonstrated experience in curriculum development in peacebuilding and community dialogue facilitation processes.
- Able to formulate learning objectives in developing an integrated resource pack.
- Excellent analytical and communication skills.
- Ability to work under pressure, meet deadlines and show flexibility.
- The local knowledge of the South Sudan context is an asset.
- Excellent command of English.

- Introduction (including the consultant's understanding of the required assignment).

Financial Proposal Submission and Evaluation

- The financial proposal is expected to show all the direct costs related to the implementation of the assignment.
- Please use the table below, and do NOT add any additional budget lines, to facilitate evaluating and comparing the financial offers equally.
- The financial proposal carries 30% of the total score.
- Consultants shall submit Technical and Financial Proposals in a package containing two separate envelopes or attachments as follows.
 - a. The first envelope must be marked "TECHNICAL PROPOSAL" and shall contain one original hard copy of the technical proposal.
 - b. The second envelope must be marked "FINANCIAL PROPOSAL" and shall contain one original hard copy of the financial proposal.
 - c. All those who are interested in sending via e-mail, please make sure that you send one email with technical and financial attachments together. Please note that for the financial proposal, add the password. If your technical proposal is shortlisted for further review, you will be requested to submit the password for the financial proposal only. Applications submitted without a password for financial proposal will be disqualified.
- All offers shall be signed and stamped by the consultant.
- No financial information shall be contained in the Technical Proposal; otherwise, the offer will be canceled and excluded from the evaluation process.
- Consultants shall not be entitled to compensation related to the costs of preparing the proposals.
- The consultant will provide a detailed budget for resource pack development (at VAT 0). FCA will then add the VAT according to the governing legislation.

Proposals evaluation process

- The evaluation of proposals and selection of the consultant will be made using the Quality and Cost Based Selection, with a total score calculated out of 100%, of which 70% is the weight of the Technical Proposal and 30% is the weight of Financial Proposal.
- Only Technical Proposals will be opened on the submission date. Financial Proposals remain sealed until the technical evaluation is completed.
- The consultant with the highest total score (sum of technical and financial scores) will be considered as the winner of the consultancy assignment and will be invited for contract negotiations and ultimately to sign the Contract.
- The Technical and Financial Proposals of the successful bidder and negotiation minutes will form part of the Contract.

8. Reporting

• The consultant (firm) receives the necessary guidance and directly reports to the FCA peace and Reconciliation Advisor.
