• To support timely and secure cash payments to staff, volunteers, and vendors within South Sudan especially in Western Equatoria State, Unity state (Yida) and Central Equatoria State among other areas of operations for the financial year 2024.

General Requirements

- Familiarize with CMMB's mission, vision, and values to ensure alignment with your proposal.
- Have a minimum of 3 years of experience in delivery of cash transfer services to organizations, corporations, and/or foundations in South Sudan.

Proposal Contents/Requirements

The money transfer/delivery service proposal should include, as a minimum the following:

- Proof of Company Registration in South Sudan.
- A copy of the audited financial statements for last two years (balance sheet and Income statement).
- The details of the names, address, and contact details of three (3) clients for whom the same types of services were provided in various and disperse geographic locations. CMMB reserves the right to contact these references, without notifying the Tenderer.
- Valid Tax Clearance Certificate.
- Proof of experience in cash transfers/ delivery services.
- Proof of business license to provide financial services.
- Full technical and Commercial proposal (Locations, payment /reimbursement terms, prices, delivery timeline, payment methods etc.)
- Company profile clearly indicating the physical address of the business, Directors, and shareholders.

Technical and Commercial Proposal Requirements

The technical and commercial proposal should include as a minimum the following: -



- Include specific areas (Counties, Towns) in Western Equatoria State and Central Equatoria State where you can deliver cash timely.
- Detailed price offers with explanatory notes for clarity where necessary.
- Include a timeline for cash delivery by location (WES, CES & Unity (Yida) (See location annexed below)
- Clarify on mechanism of provision of proof of payments to CMMB.
- Clarify on payment terms.
- Clarify on disbursement and reimbursement mechanism.

Opening, evaluation of tenders and selection criteria

The proposal shall be opened and evaluated by CMMB Procurement Evaluation Committee in line with CMMB procurement policy.

Contract will be awarded to the technically, commercially, and administratively compliant vendor that has demonstrated most economically advantageous, considering the quality of the services proposed and capacity that meets CMMB eligibility requirements.

Tenders will be evaluated on the criteria listed below as a minimum:

- Ability to meet the requirements of the Call for tenders.
- Compliance with CMMB terms and conditions
- Total price/cost is in line with CMMB expectations.





- Demonstrable ability to perform all functions related to the scope within the time specified.
- Bidders' references
- Bidders' service offer
- Value added services etc.

In the interests of transparency and equal treatment and without being able to modify their tenders, bidders may be required, at the sole written request of the evaluation committee, to provide clarifications. Any such request for clarification must not seek the correction of formal errors or of major restrictions affecting the performance of the contract or distorting competition.

Any attempt by a bidder to influence the evaluation committee in the process of examination, clarification, evaluation, and comparison of tenders, to obtain information on how the procedure is progressing concerning the award of the contract will result in the immediate rejection of tender. No liability can be accepted for late delivery of tenders. Late tenders will be rejected and will not be evaluated.
