

**REQUEST FOR EXPRESSIONS OF INTEREST
(CONSULTING SERVICES – FIRM)
UNDER FRAME WORK AGREEMENT ARRANGEMENT**

1. Overview

HealthNet TPO (HNTPO) is an International NGO duly registered and operating in South Sudan specifically in Central Equatoria State, Western Bahr El Ghazal State and Northern Bahr El Ghazal State. HealthNet TPO works with local communities and government authorities to deliver basic health services with support from the Health Pooled Fund (HPF3).

As HPF3 implementing partner, HealthNet TPO is required to ensure that health facility structures (PHCUs, PHCCs, and hospitals) in the above locations are from time to time renovated and maintained in a sound condition. The renovations and maintenance of health facility structures will be done following professionally acceptable Civil and Building Engineering Standards.

HealthNet TPO therefore wishes to contract a competent National Engineering Consulting firm to undertake the assessment, design, preparation of bills of quantities, preparation of bid documents, bid evaluation and supervision of contractors that will be solicited. Interested consultants must provide information indicating that they are qualified to perform the services (with Proof of all relevant Registrations to carry out business in South Sudan, Capability statement detailing the firm's general qualification, description of similar assignments, experience in similar conditions, availability of appropriate skills among staffs, and references, etc.)

2. Period and Duration of the Consultancy

The successful firm will enter into a framework agreement with HealthNet TPO to provide engineering consultancy services for a period of 1 year.

3. Scope and Focus of the Assignment/ Key deliverables

The selected consultant will ensure that the renovations and maintenance of health facility infrastructures are done following professionally acceptable procedures including;

- preliminary assessment (damages) of the structures,
- Conducting environmental impact assessment
- preparation of Engineering Design drawings where applicable



- Preparation of BOQs
- Preparation of bid Documents
- Evaluation bids
- Supervision of works to ensure that quality of materials and workmanship is as per agreed standard and design
- Periodic generation of certificates, (interim , final)
- Commissioning and Decommissioning of the works (renovations/maintenance)

4. Qualifications/Necessary skills and Experience of the Consultants

- a) Consultant must be legally registered company (Copy of company incorporation certificate) with at least 5 years construction experiences
- b) Must have valid Tax clearance certificate
- c) Prior experience of Turnkey projects
- d) The consultant must provide their list of qualified and experienced engineers. The team leader engineers must have at least 5years of graduate experiences in similar assignments
- e) The firm must indicate the physical address where they are based within South Sudan

5. Terms and Conditions

- a) The call for the EOI by HealthNet TPO and submission of proposal by a firm does not form any contract.
- b) HealthNet TPO does cover any cost associated with preparation and submission of the EOI
- c) Final Cost Negotiation Shall be done with selected consultant
- d) HealthNet TPO has the right to terminate the solicitation of the consultant should the negotiation fails.

6. Evaluation Criteria:

- a) Up to date relevant documents (tax clearance, registrations etc) 10 marks
- b) Good qualification of the proposed team with relevant experience. 40marks
- c) Relevant Working past Experience (Civil and building Engineering, turnkey projects etc) and adequacy for the assignment of not less than 5 years: 50 marks
- d) Total points: 100 points
