Request for Quotation (RFQ) for Large Cinema Screening Equipment for Amalna South Sudan

I. Background

- d) The Supplier MUST accept 100% payment through bank transfers after supplying the equipment.
- e) The supplier when selected should be able to supply the equipment in 7 days' time from the day of signing the contract.
- f) Provide brief Narrative proposal describing the process and methodology of supplying the equipment; timeframe, and how he/she will deliver the equipment.
- g) Financial proposal should indicate Item by Item, cost and total cost attached to the technical proposal.
