### Job purpose:

The nutrition officer is responsible for implementing nutrition surveillance and prevention of malnutrition through facility-based information kiosk in coordination with partner NGOs, and communities. Developing appropriate communications in preventing malnutrition among under five years children and foster behavior change in the target population through the use BHW's and EPI vaccinators. He/she shall liaise with nutrition NGO implementation partners, County Health Departments and S MoH on all aspects of nutrition programming for children less than five years, pregnant and lactating mothers.

### **KEY RESPONSIBILITIES**

- Leads in regular and monitoring visits to the health facilities and community documenting key nutrition concerns.
- Gathers relevant information on the HPF-3 project to enhance informed accurate decision making and sharing information with / from local communities to improve Nutrition standards in the community.

- Attend focused group discussions and other related community level meeting to identify constraints to success of nutrition interventions.
- Contribute in data collection, nutrition surveys, campaigns and monitoring of nutrition trends.
- Support engagement of communities in improved nutrition practice including promotion of traditional food security structures.
- Ensure that cross cutting issues such as protection, gender, environmen, HIV are address and mainstreamed in the project including Covid-19 pandemic
- Participates in the field team monitoring of HPF-3 project interventions
- Performs any other related duties that may be assigned by line manager
